MAJOR GENERAL JOEL D. JACKSON

Maj. Gen. Joel D. Jackson is dual-hatted as Commander of the Air Force District of Washington and the 320th Air Expeditionary Wing, headquartered at Joint Base Andrews, Maryland. AFDW is the Air Force component to the Joint Forces Headquarters-National Capital Region and is responsible for organizing, training and equipping combat forces for aerospace expeditionary forces, homeland operations, civil support, national special security events and ceremonial events. AFDW also provides major-command-level support for 33,000 military and civilian personnel assigned worldwide.

General Jackson graduated from the U.S. Air Force Academy in 1992 and is a graduate of the Air War College. He earned additional master's degrees in Aeronautical Engineering and Administrative Management from the University of Washington and George Washington University, respectively.

General Jackson is a command pilot with more than 4,800 flight hours. He has flown combat and combat support missions during operations SOUTHERN WATCH, ENDURING FREEDOM and IRAQI FREEDOM, and served in a variety of positions at the squadron, group and wing levels as well as positions at Air Mobility Command, the Joint Staff, the Air Staff, U.S. Transportation Command and the Office of the Secretary of Defense. He has served twice as a Wing Commander, once as an Air Expeditionary Wing Vice Commander and commanded two squadrons including one in Southwest Asia. Prior to his current assignment, General Jackson was Director of Operations, Strategic Deterrence and Nuclear Integration, Headquarters Air Mobility Command, Scott AFB, III

AFDW is the Air Force component to the Joint Forces Headquarters-National Capital Region and is responsible for organizing, training and equipping combat forces for aerospace expeditionary missions, homeland security operations, civil support, national special security events and ceremonial events. AFDW also provides major-command-level support for 33,000 military and civilian personnel assigned to 1,758 units stationed at 500 locations in 108 countries worldwide.

Col. Guill was commissioned in 1998 through the USAF Officer Training School. He has served in a variety of positions at the Numbered Air Force, Headquarters Air Force and Combatant Command levels, including an assignment as the Commander of the Air Force Security Forces Center (AFSFC), Joint Base San Antonio (JBSA) Lackland, Texas. Col. Guill also supervised three geographically-separated Air Force Detachments, the Desert Defender Readiness Training Center at Fort Bliss, Texas and two corrections facilities located at Marine Corps Air Station Miramar, California and Fort Leavenworth, Kansas.

Ms. Leigh Anne Bierstine is a US Air Force Senior Materiel Leader serving as the Deputy, Program Executive Officer for Combat and Mission Support, Office of the Assistant Secretary of the Air Force for Acquisition, Technology & Logistics, Washington, D.C. She provides leadership support for the acquisition of US Air Force and US Space Force services and is responsible for a portfolio of more than \$164 billion in existing and planned contracts across the Department of the Air Force. Prior to her current assignment, Ms. Bierstine served as the Senior Materiel Leader for the F-35 Joint Strike Fighter's Combat Data Systems Program Management Office at the F-35 Joint Program Office in Washington D.C, where she was responsible for the development, production and sustainment of the F-35's Reprogramming and Mission Planning Enterprise.

During her time at Wright-Patterson AFB, she also oversaw multiple acquisition programs in the B-1 Bomber Division including key radar and datalink modifications to the B-1 fleet.
