Because mo Systems Analysts and Computer Programmers who are paid at le: at least \$684 per week if paid on a salary or fee basis) likely quali computer professionals under 29 U.S.C. 213(a)(1) and 29 U.S.C. 21 determination may not include wage rates for all occupations wit families. In such instances, a conformance will be necessary if th employees in these job families working on the contract.

Job titles vary widely and change quickly in the computer industri determinative of whether an employee is an exempt computer pr exempt, computer employees who satisfy the compensation requ a primary duty that consists of:

(1) The application of systems analysis techniques and procedu

consulting with users, to determine hardware, software or system specifications;

(2) The design, development, documentation, analysis, creation modification of computer systems or programs, including prototy related to user or system design specifications;

(3) The design, documentation, testing, creation or modification programs related to machine operating systems; or

(4) A combination of the aforementioned duties, the performan requires the same level of skills. (29 C.F.R. 541.400).

Any computer employee who meets the applicable compensation above duties test qualifies as an exempt computer professional under section 13(a)(1) and section 13(a)(17) of the Fair Labor Standards Act. (F Bulletin No. 2006-3 (Dec. 14, 2006)). Accordingly, this wage determination apply to any exempt computer employee regardless of which of the duties are utilized.

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - If you work at night as part of a regular tour of duty, you will earn a night shift differential and receive an additional 10% of basic pay for any hours worked at night. If you are a full-time employed (40 hours a week) and Sunday is regularly scheduled workweek, you are paid at your rate of basic pay plus a premium of 25% of your basic rate for each hour of Sunday work (i.e. occasional work on Sunday outside the normal tour of duty is not overtime work).

**** HAZARDOUS PAY DIFFERENTIAL ****

An 8 percent differential is applicable to employees employed in operations that represents a high degree of hazard when working with or in close proximity to ordnance, explosives, and incendiary materials. This includes work involving screening, blending, drying, mixing, and pressing of sensitive ordnance and pyrotechnic compositions such as lead azide, black powder and All dry-house activities involving propellants or explosives. Demolition, modification, renovation, demolition, and maintenance operation ordnance, explosives and incendiary materials. All operations involving

and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a represents a low degree of hazard when working with, or in close ordnance, (or employees possibly adjacent to) explosives and incendiary ordnance which involves potential injury such as laceration of hands, face, or other body parts of an employee engaged in the operation, irritation of the skin, minor burns, or minimal damage to immediate or adjacent work area or equipment. The provisions of this wage determination involving, unloading, storage, and hauling of ordnance, incendiary ordnance material other than small arms ammunition are only applicable to work that has been specifically designated as involving ordnance, explosives, and incendiary material differential pay.

**** UNIFORM ALLOWANCE ****

If employees are required to wear uniforms in the performance of their duties (either by the terms of the Government contract, by the employer, or by local law, etc.), the cost of furnishing such uniforms and maintaining them (including laundering or dry cleaning) such uniforms is an expense that may be added to the employee's hourly rate where such cost reduces the hourly rate below that required by this wage determination. The Department of Labor will accept payment in lieu of such cost if the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the cost of the uniforms. In addition, where uniform cleaning and maintenance is the responsibility of the employee, all contractors and subcontractors shall, under this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount, or the furnishing of convincing affirmative proof as to the actual cost), reimburse all employees for the cost of uniform and maintenance at a rate of \$3.35 per week (or \$.67 cents per day) for those instances where the uniforms furnished are made of "washable" materials, may be routinely washed and dried with other personnel's uniforms and not require any special treatment such as dry cleaning, daily washing, or special laundering in order to meet the cleanliness or appearance standards required by the Government contract, by the contractor, by law, or by the employer. If there is no requirement that employees be reimbursed for uniform and maintenance costs, there is no requirement that employees be reimbursed for uniform and maintenance costs.

**** SERVICE CONTRACT ACT DIRECTORY OF OCCUPATIONS ****

The duties of employees under job titles listed are those describe ""Service Contract Act Directory of Occupations"", Fifth Edition (dated September 2015, unless otherwise indicated.

**** REQUEST FOR AUTHORIZATION OF ADDITIONAL CLASSIFIC. Form 1444 (SF-1444) ****

Conformance Process:

The contracting officer shall require that any class of service employees not listed herein and which is to be employed under the contract to be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a relationship (i.e., appropriate level of skill comparison) between such classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted classification (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make the final determination of conformed classification, wage rate, and/or fringe benefits shall be paid to all employees performing in the classification from the date of work on which contract work is performed by them in the classification to pay such unlisted employees the compensation agreed upon by the contractor and parties and/or fully determined by the Wage and Hour Division from the date such class of employees commenced contract work shall be included in this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract, a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for each unlisted occupation(s) and computes a proposed rate(s).
- 2) After contract award, the contractor prepares a written report detailing the proposed classification title(s), a Federal grade equivalency (if applicable), the proposed classification(s), job description(s), and rationale for proposed rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class

performs any contract work.

3) The contracting officer reviews the proposed action and promulgation of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employee. The contractor must submit the proposed action to the Wage and Hour Division, Department of Labor, Wage and Hour Division, for review (See 29 CFR 4.6(b)(2)(iii)).

4) Within 30 days of receipt, the Wage and Hour Division approves or disapproves the action via transmittal to the agency contracting officer. The contracting officer notifies the contractor that additional time will be required to complete the request.

5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.


6) Each affected employee shall be furnished by the contractor with a copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).


Information required by the Regulations must be submitted on SI Form 1000.

When preparing a conformance request, the "Service Contract Act Occupations" should be used to compare job definitions to ensure that the requested jobs are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required duties that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or substitute classifications listed in the wage determination (See 29 CFR 4.15).
