Recently, [REDACTED] took on the company [REDACTED] the previous single source company who had an agreement with VDOT E-Z Pass. With the acquiring of the government contracts of [REDACTED] has taken on the agreement for operations support between VDOT. [REDACTED] was initially awarded the VDOT contract to execute these operations because of their ability to meet day-to-day functions in connection to E-Z Pass operations. The service for E-Z Pass transponders is needed to complete daily operations for OCHR Norfolk Operations Center. Due to the agreement for operations support between [REDACTED] and VDOT, the Navy is required to also contract with [REDACTED] for E-Z Pass account requirements. Therefore, [REDACTED] is the only source capable of fulfilling this requirement.
