## **Contractor Questions and Government Responses**

Can the Government provide a photo where the compressor will be installed? Yes

What is the pipe size we'll be connecting to? 1 inch

Is there a forklift available? Contractor will need to supply

Can we set up a site visit for our technicians to understand the scope of work for the installation? Yes

How accessible are the compressors for installation? Can drive into them from ground level

Will the government allow a slightly lower CFM output of 141 CFM as a replacement for the 149CFM as specified? Yes, we can go as low as 120 CFM @ 125 PSI

Do you require a refrigerated or desiccant dryer? How many? Are any after filters required? desiccant

Do you require training? No, would like an operation/ maintenance manual if available

Do you require startup for the compressor? Yes

Can we substitute a higher HP compressor to meet the requirement for 149 cfm @ 115 psi? Is 149 cfm the minimum requirement? Yes

Is the compressor a fixed or variable speed? Variable, prefer rotary screw

Is the 120-gallon tank remote (not tank mounted)? Tank mounted, feeds a 250-gallon tank

In what building(s) will the compressor and backup system be located? Building 641

Are the power drops adjacent to installation locations? Yes

What is the mfg. of compressor that this request is based off of? To my knowledge, there is not a fixed speed 30HP compressor on the market that can deliver 149 CFM. I pulled from a variable speed Kaishan, 30 HP Rotary Screw Air Compressor with Variable Speed Drive, we can go as low as 120 CFM @ 125 PSI

Is this for a fixed speed, or variable speed drive compressor? Fixed, prefer screw drive

Do you want a compressor with an Integral Air Dryer, or a stand-alone air dryer separate from the compressor? an Integral Air Dryer

At 120-gallon tank is extremely small for a 150-cfm system. The rule of thumb is to have 3-5 gallons of receiver capacity PER CFM of the cycling air compressor. That would put us somewhere in the ballpark of a 500-Gal. receiver tank (400-gal as an absolute minimum). There are 2 compressors that feed a 250-gallon tank, so the combined capacity is in the range you are asking about

What are you looking for in terms of an installation? Install, test, start up
