No, there is a rollup door that is 12' tall and 7'10" wide

2. Can you please provide the manufacturer which the specifications are written around.

The manufacturer that we wrote the specifications around was PortaKing.

1. Do you have further specifications as to the build out of the office space, such as number of offices needed, power and data requirements, or is this simply for storage of lab and pharmacy materials?

This office space will be essentially an open room for the warehouse to operate inside and receive materials. It will require no inside partitions or separation through the space. The idea is for it to be a bullpen the materials handlers to bring carts of supplies to receive through the double doors where they can open the packages to verify the correct items were shipped. The power is to use modular wiring run to a subpanel and the data will have ports made and the VA will run the data cabling.

2. Can you provide the location on the campus the temporary facility will be located and where the power can be tied in?

The location on campus is building 8 on the top side this is not a temporary facility however this plan is designed to be a permanent solution to provide the employees with a suitable climate controlled area to accomplish their work. The power will be tied in to the existing building power panel however the VA electricians will be the ones connecting the power from the main panel to the sub panel. All of the power requirements for this project should be modularly wired to a subpanel the VA electricians will then "plug into" after the office space is constructed.
