The unit prices listed in the table is the maximum price for the countries minutes, texts, data, and GB etc. that can be charged on the Task Order unless and until contractor provides the Ordering Officer and COR written support for any price increase within a reasonable time period. No upward adjustments shall be made retroactively.
