1. The purpose of amendment 0009 to solicitation SPE603-22-R-0510 is to incorporate the following change:

a. To provide and incorporate answers to questions regarding Amendment 0008 and the PWS of the MCB Quantico procurement.

Question 1: Is the Government requiring the costs of property restoration to be included in this proposal submittal? Additionally, there is no CLIN to price this if that is the intention. There was no discussion or clarification on the government's part when the PWS was modified. Please clarify the requirement.

Answer: Paragraph C-1.3.10 is only requiring a Property Restoration Plan to be provided with the proposal. No cost data is being requested at this time, nor should it be included in the Property Restoration Plan until requested by the Contracting Officer.

Question 2: Question 29 in Amendment 0008 requested detailed information on the vehicles utilizing the Dispenser area; the financial impact on project construction costs vary significantly depending on requirements. The information provided offers some insight into what we are designing for, however, more specific information is needed for pavement and site layout design:

- A. The width, height and weight given in the response is not legal on most public highways. The type of vehicle (Truck) or a picture would be helpful.
- B. In addition to total weight and axles, the number of wheels on each axle is needed for pavement design.
- C. Please verify the turning radius of 93 feet. The typical outer turn radius is less than 50 feet.
- D. Is there a cab to this vehicle (WB-40 Semi-trailer) or one single unit?
- E. Please provide the number of traffic cycles/week or month for the largest vehicle, heaviest vehicle, and vehicle with largest turning radii.

Answer: Proposals should reflect a facility that will meet the vehicle weight/dimensions/turning radius of the PWS to include all amendments.

Question 3: Does the government provide the fire system hardware or does the contractor purchase the hardware from Kingfisher?

Answer: The Government will not provide the hardware from Kingfisher and the proposals should reflect all costs associated with providing a facility to meet the requirements of the PWS to include all amendments.
