SUMMARY OF CHANGES

The following have been added by full text:

QUESTIONS AND ANSWERS

1) Will the Naval Warfare Center allow for IP65 in rugged tablets instead of IP66 to allow for more vendors to respond offering more product choices for U.S. Navy?

IP65 is minimum requirement, anything greater will be evaluated more favorably.

2) Will the Naval Warfare Center allow for rugged tablets with MIL-810H and MIL-461G, but not certified for MIL-S-901D and MIL-S-167?

Minimum specs must be MIL-S-901D and MIL-S-167, provide copy of test report.

3) It calls for a 16:9 ratio, this would imply that a 1920x1080 resolution is acceptable. The called out resolution of 1920x1200 is a 16:10 ratio and not commonly found in the commercial tablet market. The two lines are conflicting and I was hoping for clarification?

16:9 ratio is the correct aspect ratio with 1920x1080 resolution.

4) The spec asks for a 12"-14" screen. Is 11.6" acceptable?

Not acceptable
