**1.0 INTRODUCTION**

Brookhaven Science Associates, LLC (herein known as “BSA”), operator of Brookhaven National Laboratory (BNL) under a Prime Contract with the U.S. Department of Energy (DOE) is authorized to issue this Request for Quotation (RFQ). The Offeror shall quote its most favorable price and technical approach because of the possibility that award will be made without discussion of the quote received.

**2.0 SCOPE OVERVIEW**

Scope: This RFQ is for driver qualification file management. Requirements for this solicitation are outlined in the attached DRAFT Award and Appendix A\_ Quotation Pricing Sheet.

DRAFT Award: Offeror shall thoroughly review the attached DRAFT Award and quote accordingly. The DRAFT Award is provided for preliminary review purposes and is an example of what the final Award will include. The content of the DRAFT Award is subject to change prior to execution of the Final Award.

NAICS: The North American Industry Classification System (NAICS) Code for this RFQ is 561499. The stated size standard is \$15. The stated size shall be the sole determining factor as to classification (small or large business) of an Offeror. It is the responsibility of the Offeror to affirm its Representations and Certifications and size status are accurate and up to date in System for Award Management (SAM) within Appendix A\_Pricing Sheet.

### **3.0 BASIS OF AWARD**

Award, if any, will be made to the responsive and responsible Offeror whose evaluated quote provide for a fair and reasonable price after satisfying all requirements of this RFQ. The resultant Firm Fixed Price Award shall be subject to the terms and conditions as outlined in attached DRAFT Award.

### **4.0 QUOTE SUBMITTAL REQUIREMENTS**

General: Offeror that fails to provide all requirements of this RFQ may be deemed non-responsive and may not be considered for Award. Any exceptions shall be noted accordingly; however, the Offeror shall not construe noted exceptions, if any, to be accepted by BSA.

Questions: Should Offeror have questions, all questions must be submitted in writing to Contracts Specialist by the Questions Due Date detailed on Page 1 of this RFQ. Questions received late may not be answered. Questions and BSA's answers will be transmitted in writing to all Offerors, if deemed pertinent.

Submission of Quote: Quotes are due by the Quote Due Date as detailed on Page 1 of this RFQ. Quotations, including their withdrawal or modification, received after the Quote Due Date shall be considered late. Such responses will only be considered if it is in BSA's best interest to do so.

Quotes shall include:

- Price Quote:
  - The Offeror shall complete and return attached Appendix A\_Quotation Pricing Sheet. Pricing shall remain firm for sixty (60) days to allow time for review, selection, and award. Prices shall be quoted in U.S. Dollars.

  - **System For Award Management (SAM)**: Please provide SAM Unique Entity Identification (UEI) Number within Appendix A\_Pricing Sheet, as well as affirm Representations and Certifications and size status are accurate and up to date in SAM.
