This announcement constitutes a Sources Sought Notice. This is not a request for quotation (RFQ) or a request for proposal (RFP).


The purpose of this Sources Sought Notice is to determine if there are two (2) or more capable contractors that can perform the requirements of a planned contract. For this reason, it is important that potential contractors respond to this Sources Sought Notice with the requested documents. The submissions received by the contracting office in response to this Sources Sought Notice may lead to determining whether the procurement shall be conducted as full and open competition, restricted competition, or sole source in accordance with Federal Acquisition Regulation (FAR) 6.302. The Government intends to solicit this requirement as “Brand Name or Equal.”

This Sources Sought Notice is to request information for the procurement of a Security Agent Protective Kit. Additional information is provided in the table below and the associated spreadsheet.
