1.0 Scope of Work

Purchase of thermal binoculars for use by Wildlife Services projects in Nevada.

2.0 Background

Nevada Wildlife Services (WS) is responsible for several projects that require after-dark operations, including assessment of population sizes, reduction of excessive predators targeting crops, livestock, and/or public health, and control of feral swine populations. Thermal optics are required for these operations to be successful, and monocular sighting instruments cause eye fatigue to develop faster, decreasing performance and time spent in the field. For this reason, the program intends to purchase thermal binoculars.

3.0 Contract Type & Specifications

Nevada WS intends to purchase seven (7) thermal binoculars meeting the specifications described below through a firm fixed price purchase order.

(1) The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for "covered telecommunications equipment or services".

(2) The Offeror represents that—

(i) It ☐ does, ☐ does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(ii) After conducting a reasonable inquiry for purposes of this representation, that it ☐ does, ☐ does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.
