The current Internet and phone services are unreliable and frequently disconnect when accidents and construction cut the fiber lines between Gallup and Albuquerque. When events like this happen, our patient care services are extremely limited if not suspended. This impacts our ability to transfer patients to other higher level healthcare facilities.

Sacred Winds in the only Internet Service Provider in the area that has redundant (two service fiber lines) lines between Gallup Service Unit and Albuquerque, NM. One runs parallel with Interstate 40 and the other routes up to Farmington, NM over to Albuquerque. The two routes ensure reliable Internet service is always available, specifically when incidents or accidents happen along Interstate-40 corridor. No other ISP has this redundant capability that Sacred Winds has incorporated into their network architecture. Redundancy or having a backup ISP is critical to provide adequate patient care, communicating via wifi calling with other hospitals, and medical air transportation when phone or cell phone coverage is not available. The last outage left our facility without Internet, landline phones and limited cell service for 14 hours. Similar incidents with lengthy outages have been occurring.
