Puget Sound Naval Shipyard needs the original contractor for the controller replacement to modify the door controls on a heat treating furnace Asset #: 4523A-C0052 located at PSNS Bldg. 452. for Door Position Control Kit Model DC-17KIT (Kit includes Installation) and required delivery date of April 30, 2023.

Specific characteristics of the material or service that limit the availability to a sole source or particular brand name (unique features, function of the item, etc.). Describe in detail why only this suggested source can furnish the requirements to the exclusion of other sources.

CompuDAS installed new controller internals for Furnace 15 in 2020. It was subsequently identified the door controls needed to be modified to allow for partial opening and closing to reduce heat loss prior to quenching. This is a quality assurance issue for heat treatment (i.e., much higher likelihood of rejected material due to unsatisfactory quenching). Only CompuDAS can properly source and install the new components that will be required to affect the required change to the door controls to be compatible with the existing controls for the rest of the furnace.

The requested material or service represents the minimum requirements of the Government.

Due to the furnace's specific function in heat treating critical components for a wide variety of purposes, it is imperative that the door modification is compatible with the rest of the furnace—especially the overall controller, which CompuDAS installed in 2020.
