16. REMARKS The contractor shall submit a draft set of Level III Production Drawings concurrent with delivery of the First Article Test Report (FAT-R). This draft submission shall include all changes resulting from the Physical Configuration Audit (PCA) and First Article Test (FAT). The government shall provide comments within (thirty) 30 days of submission and all final production/configuration drawing updates made w/in thirty (30) days thereafter. Drawings developed shall be capable of providing sufficient engineering definition/detail to enable a competent manufacturer to produce and maintain complete quality control of item(s). Physical and performance characteristics shall be defined to allow interchangeability with the original design and can be obtained without resorting to additional product design effort, additional design data, or recourse to the original design activity. Drawings produced from this effort shall provide the necessary data to permit competitive procurement of items substantially identical to the original item(s). Final Drawing format, for drawings generated under the Engineering Change Proposal (ECP), shall conform to the following: Format: The contractor shall produce a drawing package/Solidworks 2021 compatible files including all necessary parts list and associated information. Only drawing sizes A, B, C and D (ANSI Y14.1) shall be used for the drawings. The contractor shall deliver Solidworks 2021 compatible files to the government to satisfy this requirement. Dimensions: Decimal inch dimensioning shall be utilized on drawings except where certain commercial commodities are identified by standardized nominal designations such as pipe and lumber size, where industry standards dictate the use of fractions for non-rigid components (textiles, rubber, etc.) or for items that would normally be cut/fabricated using sheet metal. All drawings shall be in accordance with DI-SESS-81000E and submitted in Solidworks 2021 format, with one .dwg file per sheet of drawings. a. Group I. Definition - Data which is not otherwise essential to the contractor's performance of the primary contracted effort (production, development, testing, and administration) but which is required by DD Form 1423.

Estimated Price - Costs to be included under Group I are those applicable to preparing and assembling the data item in conformance with Government requirements, and the administration and other expenses related to reproducing and delivering such data items to the Government.

b. Group II. Definition - Data which is essential to the performance of the primary contracted effort but the contractor is required to perform additional work to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, or quality of the data item.

Estimated Price - Costs to be included under Group II are those incurred over and above the cost of the essential data item without conforming to Government requirements, and the administrative and other expenses related to reproducing and delivering such data item to the Government.

c. Group III. Definition - Data which the contractor must develop for his internal use in performance of the primary contracted effort and does not require any substantial change to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, and quality of the data item.

Estimated Price - Costs to be included under Group III are the administrative and other expenses related to reproducing and delivering such data item to the Government.

d. Group IV. Definition - Data which is developed by the contractor as part of his normal operating procedures and his effort in supplying these data to the Government is minimal.

Estimated Price - Group IV items should normally be shown on the DD Form 1423 at no cost.

Item 18. For each data item, enter an amount equal to that portion of the total price which is estimated to be attributable to the production or development for the Government of that item of data. These estimated data prices shall be developed only from those costs which will be incurred as a direct result of the requirement to supply the data, over and above those costs which would otherwise be incurred in performance of the contract if no data were required. The estimated data prices shall not include any amount for rights in data. The Government's right to use the data shall be governed by the pertinent provisions of the contract.
