

**COMBINED SYNOPSIS/SOLICITATION ‘COMBO’:  
Hangar 8 Shelving Unit Move**

This is a combined synopsis/solicitation for commercial products or commercial services prepared in accordance with the format in subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a written solicitation will not be issued.

Solicitation FA500023Q0040 is issued as a Request for Quotation (RFQ). Only written offers will be accepted (oral offers will not be accepted). The Government intends to establish a single firm fixed priced contract resulting from this solicitation to the responsible contractor whose quote is most advantageous to the Government, price and other factors considered. All firms or individuals responding must be registered with the System for Award Management (SAM) IAW 52.204-7 Alternate I (Oct 2018).

**Purpose:**

New requirement for dismantling, palletizing, relocation, leveling and reassembly. The 962 AMU is moving from Hangar 3 Bldg: 10571 to Hangar 8 Bldg: 14410 and require the mobile shelving unit in the maintenance support section to be professionally moved. The Contractor shall accomplish dismantling, palletizing, loading, transporting, unloading, leveling, and rebuilding of mobile shelving unit and removal of trash and transportation equipment. The mobile expanding shelving unit is 27 feet by 15 feet by 8 feet. It includes 1 stationary shelf and 4 moving shelves; each are 15 feet by 4 feet by 8 feet. Under the shelves there is a rail unit that needs to be squared and level for the shelves to move properly. Prepare the new site for reinstall and rebuild of the shelving unit. Projected completion of this will conclude by the End of May 2023.

**Description of agreement:**

The 673rd Contracting Squadron at Joint Base Elmendorf-Richardson, Alaska, will award a single contract resulting from this RFQ to the responsible offeror that offers the approved service, is technically acceptable and is found to be the best value to the Government.

**Supplies or Services:**

The government intends to establish a firm-fixed price contract for the following:

dismantling, palletizing, loading, transporting, unloading, leveling, and rebuilding of mobile shelving unit and removal of trash and transportation equipment, with possibility of leveling the ground for the mobile expanding shelving unit that is 27 feet by 15 feet by 8 feet.

No additional contract requirements apply to this acquisition.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.
