On January 9<sup>th</sup> 2023 during a ERAT inspection, it was discovered that Repair Division had 14 gauges and 3 low pressure switches out of calibration. A clean room is required for the calibration of this equipment. The [REDACTED] does not possess a clean room, and does not have access to one other than at [REDACTED]. The [REDACTED] needs these gauges and switches so that it can safely operate the ship's HPBAC, which is key to the [REDACTED] damage control capabilities. Additionally these components are critical to the completion of Damage Control Material Assessment.

During the Same ERAT inspection it was also discovered that Auxiliary Division had 7 out of calibration detroit switches for the ship's freeze box and chill box. The switches are important for maintaining an accurate temperature, via a capillary tube that extends into the box. The chill/freez box allow food service members to store food inside the box. The switches are to be calibrated yearly. Ships force lacks the capabilities to calibrate the switches because there is no refrigerant onboard for proper testing of the switches. The only readily available refrigerant we need for the calibration can be obtained through [REDACTED]. These switches are critical to crew move aboard which must be completed for the [REDACTED] complete the maintenance avail.

The detroit switches for the freeze/chill box are critical items for crew move aboard and will prevent USS San Antonio from completing its' maintenance avail.
