Tanks will be filled according to contractor's needs to support mission requirements</p> <p>Question 19: Reference PWS C-3.1, MCINCR-MCBQ Automated Fuel Dispensing Facility:</p> <p>m. Correct to assume no solid rock removal is required?</p> <p>Answer: There has been no Geotechnical survey completed and any solid rock removal will need to be determined by the contractor.</p> <p>n. Correct to assume no undercutting and replacement of existing soil will be necessary?</p> <p>Answer: There has been no Geotechnical survey completed and any undercutting and replacement of existing soil will need to be determined by the contractor.</p> <p>o. Lacking subsurface geotechnical data of the site or topographic, can we assume there is sufficient satisfactory soil for necessary cut and fill (a "balanced" site)? i. Have soil tests been done to accommodate the weight of 70 ton equipment?</p> <p>Answer: No soil tests have been conducted to accommodate the weight of 70T Equipment. NO subsurface GeoTech data has been accomplished, so plan for corrected scales and data for this area. (Soil map from Stafford and King George Counties, Virginia provided via a secure website.)</p>
