Dear Quoters: Accompanying this cover letter is a solicitation package prepared by the Federal Bureau of Prisons, for the acquisition of Subsistence Products for the Federal Correctional Complex Butner, Butner, North Carolina. This package contains all necessary information for submitting a quote.

All potential quoters are advised that this solicitation includes the clause at FAR 52.212-4 Contract terms and Conditions— Commercial Items. This clause requires all contractors doing business with the Federal government after September 30, 2004 to be registered in the CCR database at <https://sam.gov>. In conjunction with required registration in the CCR database, prospective contractors shall also complete electronic annual representations and certifications at <https://sam.gov>. Failure to complete the registration procedures outlined in this clause may result in elimination from consideration for award.

Quoters shall include their Unique Entity Identification (UEID) number in Block 17a of the Standard Form 1449, in accordance with FAR 52-212.1(j). The Contracting Officer will verify CCR, EPLS and ORCA registrations, prior to award, by entering the potential awardees' UEID number into the respective database.

Offers are due in this office no later than March 13, 2023, 1:00 p.m. Eastern Standard Time (EST). Please note, faxed offers are authorized and may be transmitted to Fax# (919) 575-5036. Quotes must be received in this office no later than the time specified as the deadline for receipt of quotes. Quotes received after the quote deadline will be handled in accordance with FAR 52.212-1(f). The anticipated date of award is March 24, 2023, with delivery beginning April 4, 2023 through June 30, 2023. The delivery day is Tuesday of each week, unless other arrangements have been made and agreed upon by the FS Administrator. NO EXCEPTIONS.

Prospective quoters are also cautioned against discussing the preparation of their quote (or any technical questions) with Government technical personnel. The circumstances of such contact, when verified, may result in non-consideration of the quote. Accordingly, all communications prior to an award will be directed to the Contract Specialists, in writing, to the aforementioned email addresses.
