- 1.1.3 Evaluations will be conducted in accordance with **52.212-2 Evaluation—Commercial Products and Commercial Services (Nov 2021)**. Quoters are responsible for ensuring completeness of quotations. The Government may evaluate solely on the information provided in the quotation. Quotations that include additional terms may be excluded from consideration. Alternate packaging equivalent to the total number of pounds specified per box of dry ice is acceptable. Quotes must indicate how the product is packaged (number of pounds per box), the minimum pounds per box shall be 50LB.

2.0 STATEMENT OF WORK

2.1 BACKGROUND: This requirement is for the United States Department of Agriculture, Animal Plant Health and Inspection Service, National Bio and Agro Defense Facility (NBAF) in Manhattan, Kansas. As the Nation's veterinary authority, Veterinary Services improves the health, productivity, and quality of life for animals and people, and maintains and promotes the safety and availability of animals, animal products, and veterinary biologics. The NBAF facility helps protect the nation's agriculture, farmers and citizens against the threat and potential impact of serious animal diseases.

2.2 OBJECTIVE: The objective of this acquisition is to obtain a supply of dry ice on a routine basis to maintain adequate amounts required by various NBAF missions.

2.3 CONTRACT TYPE: This solicitation will result in the award of a firm-fixed-price contract.

2.3.1 The payment provided for in the contract shall constitute full compensation for providing supplies, labor, supervision, equipment, incidental materials, quality control, environmental protection, meeting safety standards and performing all work under the contract in a complete and acceptable manner. Except as otherwise specified in this contract, all costs associated with incidental work shall be included in the Pricing Schedule item with which that incidental work is most closely associated. Compensation for all work shown, specified, or essential to completion of the project shall be included in the total price. The payment provided in the contract includes compensation for all risk, loss, damage, and expense arising out of the nature of the work or its prosecution, subject to the conditions of the contract.

2.3.2 Quantities specified for "Routine Supply/Delivery of Dry Ice" and "Rush Delivery" are estimated Not To Exceed (NTE) amounts for the specified period. Payment will be made based on the actual quantities received and accepted by the Government. The Government is not obligated to pay the Contractor for any amount more than the Not To Exceed quantities specified in the Pricing Schedule.

2.4 Period of Performance

The contract period of performance consists of a Base Period and Two Option Years:

Base Period: Contract Award – October 21, 2023

Option Year One: October 22, 2023 – October 21, 2024

Option Year Two: October 22, 2024 – October 21, 2025

2.5 SPECIFICATIONS

- 2.5.1** Insulated Dry Ice Containers: The contractor shall furnish and deliver four (4) easily moveable insulated containers with casters and a hinged lid for optimal dry ice sublimation control. Each insulated container shall individually hold approximately 1000+ pounds of regular pellet dry ice to facilitate storage and distribution within the labs. These containers shall become Government Property upon delivery and will remain government property at the end of the term of this contract. Each insulated container must meet the specified OSHA standards for storing Dry Ice (Solid Carbon Dioxide).
- 2.5.2** Dry ice shall be manufactured, processed, packed, transported, and stored according to the FDA's Current Good Manufacturing Practice (GCMF) regulations and Title 21, Code of Federal Regulations, Part Sec. 184.1240. Contractor shall comply with Department of Transportation regulations and specifications for marking, labeling, and delivering dry ice. All products, equipment, and services provided under the contract shall follow all applicable Federal, state, and local regulations to include 49 CFR 173.217. Medical Safety Data Sheets shall be provided upon request.
- 2.5.3** Individual Agency Ownership of Containers: The Government will procure a total of four (4) containers for even-exchange refills on a recurring basis. All procured Government-owned Containers shall be retained by the Government upon expiration of the contract.

2.6 ROUTINE SUPPLY AND DELIVERY.

- 2.6.1** Regular Recurring Weekly Delivery. Contractor shall deliver 100lbs to 2500lbs per week of 5/8" to 3/4" dry ice extruded pellets packaged as specified. Quantities delivered on a routine weekly basis will vary based on the projected estimated quantity to be used by laboratories.
- 2.6.2** Deliveries shall be made on Tuesdays between 7:00 AM to 4:00 PM. The product shall be delivered in durable boxes capable of holding 50lbs and delivered via insulated containers large enough to transport 1,000+ lbs. The Government Technical Point of Contact will call and email the contractor point of contact to specify the weekly quantity of dry ice required at least 2 business days prior to the delivery.
- 2.6.3** The ice pellets shall be delivered in 50LB boxes placed within the insulated containers on a rotating basis. During each delivery the contractor shall exchange empty insulated dry ice containers on site with insulated dry ice containers filled with the quantity of dry ice specified. The remaining empty containers shall be taken by the contractor and returned the following week with the ordered supply.
- 2.6.4** Containers shall be delivered with the proper labels attached.

2.7 RUSH DELIVERY

- 2.7.1** Rush delivery requests for supplemental quantities of dry ice may be made mid-week in addition to the above requirements in order to maintain adequate supply. The Government Technical Point of Contact will call and email the contractor point of contact to schedule rush deliveries. Rush deliveries shall be completed within 24 hours of notification.
- 2.7.2** All transportation costs for delivery shall be at the expense of the contractor.

3.0 DELIVERY: Delivery of dry ice containers shall be scheduled in advance with the Government Technical Point of Contact and completed 7 days after contract award. Routine weekly supply of dry ice shall begin with delivery of the first two containers. Deliver (FOB Destination) to the following address:

3.2 SAFETY AND SECURITY REQUIREMENTS

The contractor shall comply with all established security policies at NBAF and shall be escorted at all times while at the facility. The contractor shall complete required paperwork for access to the facility as needed at **least 72 business hours prior to estimated delivery**.

If any visitor(s) are NOT US Citizens, a Name Trace must be approved prior to completion and submission of the background check. If US Citizen, but born outside of US, proof of citizenship is required.

The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it "does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services" in paragraph (c)(2) of the provision at [52.204-26](#), or in paragraph (v)(2)(ii) of the provision at [52.212-3](#).
