<p>16. REMARKS</p> <p>Tailored: Items requiring SPIs shall be preserved and packed to meet the standards set forth for Military Packaging Level A. Commercial packing standards shall not be implemented. DD Form 2169 shall be used for SPI format and content. When continuation sheets are required, DD Form 2169C shall also be used. SPI content shall be in accordance with Appendix E of MIL-STD-2073-1.</p> <p>A Packaging Test Report shall be submitted for each SPI component as an attachment to the SPI. The contractor's SPI submittal shall include the SPI, applicable Logistics Product Data, and Packaging Test Reports. If the government finds that there is any missing information from the SPI package, the submittal will be considered incomplete and unacceptable. The submittal will remain in this status until the contractor provides all information to support the SPI.</p> <p>BLK 7 – DD 250 due with last submission only. All other submissions shall be delivered with a letter of transmittal. Contractor shall only invoice upon final government acceptance.</p> <p>BLK 12: Initial submission of SPI (A010) due thirty (30) calendar days after acceptance of Final Provisioning Parts List (A008).</p> <p>BLK 10/13: Subsequent submittals are due by the 25th of each month until all data has been submitted and is approved by the government. Final submission shall be submitted no later than ninety (90) days after government acceptance of initial submission.</p> <p>The government will determine acceptance or rejection within thirty (30) calendar days of receipt of all submissions. - Item D.** Enter name of system/item being acquired that data will support.
- Item E.** Self-explanatory (to be filled in after contract award).
- Item F.** Self-explanatory (to be filled in after contract award).
- Item G.** Signature of preparer of CDRL.
- Item H.** Date CDRL was prepared.
- Item I.** Signature of CDRL approval authority.
- Item J.** Date CDRL was approved.
- Item 1.** See DoD FAR Supplement Subpart 4.71 for proper numbering.
- Item 2.** Enter title as it appears on data acquisition document cited in Item 4.
- Item 3.** Enter subtitle of data item for further definition of data item (optional entry).

FOR THE CONTRACTOR

Item 17. Specify appropriate price group from one of the following groups of effort in developing estimated prices for each data item listed on the DD Form 1423.

a. Group I. Definition - Data which is not otherwise essential to the contractor's performance of the primary contracted effort (production, development, testing, and administration) but which is required by DD Form 1423.

Estimated Price - Costs to be included under Group I are those applicable to preparing and assembling the data item in conformance with Government requirements, and the administration and other expenses related to reproducing and delivering such data items to the Government.

b. Group II. Definition - Data which is essential to the performance of the primary contracted effort but the contractor is required to perform additional work to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, or quality of the data item.

Estimated Price - Costs to be included under Group II are those incurred over and above the cost of the essential data item without conforming to Government requirements, and the administrative and other expenses related to reproducing and delivering such data item to the Government.

c. Group III. Definition - Data which the contractor must develop for his internal use in performance of the primary contracted effort and does not require any substantial change to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, and quality of the data item.

Estimated Price - Costs to be included under Group III are the administrative and other expenses related to reproducing and delivering such data item to the Government.

d. Group IV. Definition - Data which is developed by the contractor as part of his normal operating procedures and his effort in supplying these data to the Government is minimal.

Estimated Price - Group IV items should normally be shown on the DD Form 1423 at no cost.

Item 18. For each data item, enter an amount equal to that portion of the total price which is estimated to be attributable to the production or development for the Government of that item of data. These estimated data prices shall be developed only from those costs which will be incurred as a direct result of the requirement to supply the data, over and above those costs which would otherwise be incurred in performance of the contract if no data were required. The estimated data prices shall not include any amount for rights in data. The Government's right to use the data shall be governed by the pertinent provisions of the contract.
