

PRESOLICITATION NOTICE FOR

Smart Handheld Radios, Joint Base MDL, New Jersey, 08641

The 87th Contracting Squadron, JBMDL, New Jersey intends to negotiate on a sole source basis with Persistent Systems LLC. (CAGE: 4YBU2), as the only responsible source that can provide smart handheld radios for 621st CRW at JBMDL, NJ under FAR 6.302-1, Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements. The vendor will provide the equipment to improve commercial Satellite Communication, Military Small Communications Package, and LOS communications capabilities.

It is the government's intent to procure smart Handheld Radios that meets or exceeds the specs and peripherals of the sole source brand name Persistent Systems Man Portable Unit 5 (MPU5). This acquisition will support the 621st Contingency Response Wing (621 CRW) operations, on base and various locations for deployments, trainings, and exercises.

Information received will normally be considered solely for the purpose of determining whether to conduct a competitive procurement.

If applicable, please also provide the GSA contract number and SIN the products are available under, if proposing GSA items ALL items must be available through GSA *no open* market items will be accepted.
