STATEMENT OF WORK (SOW)
PORTABLE LATRINE SERVICE / MAINTENANCE
FOR
DEFENSE INFORMATION SCHOOL (DINFOS)
April 13, 2023

1. General Information:

The mission of the Defense Information School (DINFOS) provides entry level and advanced training in public affairs, journalism, photojournalism, broadcasting, graphics, electronic imaging, broadcast systems maintenance, video production, and visual information management. Instructions are provided to officers, enlisted personnel, and civilian employees of all branches of the armed forces to prepare them for worldwide assignments within the Department of Defense.

1. Description of services and introduction: This request is for the servicing and waste removal four (4) portable latrines, consisting of three (3) regular and one (1) handicapped, located at the Defense Information School (DINFOS) Field Training Exercise (FTX) site, Fort George G. Meade, Maryland. The contractor shall provide all personnel, equipment, tools, materials, supervision, other items, and non-personnel services necessary to provide sanitary portable restroom services as defined in this PWS. The contractor shall perform to the standards in this contract.

2. Background: Portable Latrine services are required for a period of one (1) year and four (4) option years, for support of all DINFOS instructors and students utilizing the DINFOS FTX Site.

3. Objectives: To provide three safe, sanitary, and serviceable portable latrines for the DINFOS instructors and students conducting training.

4. Scope: This work involves: the contractor shall provide services for maintaining, sanitizing, once weekly waste-removal and adequate toilet supplies for four (4) portable latrines. Services are required Thursday of each week. Contractor work and planning shall include all contractor planning. The work shall be conducted in strict accordance with all applicable federal, state, and local laws, regulations, codes and directives. The contractor shall perform all related administrative service to the work which includes, but is not limited to, supplies, quality control, financial control, document storage and maintenance including record, files, reports, and historical data. The contractor will maintain libraries of documents to include all federal, state, and local laws, regulations, codes and directives.

1. **Quality control (QC):** The contractor shall develop and maintain an effective QC program to ensure services are performed in accordance with this SOW. The contractor shall develop and implement procedures to identify, prevent, and ensure non- recurrence of defective services. The contractor's QC program is the means by which he assures himself his work complies with the requirement of the contract.
2. **Recognized holidays:** The contractor is required to perform regular services to standard, except on federally recognized holidays, all weekends and days designated by DINFOS Leadership. However, the contractor will include 24 hour emergency services at no additional cost which may include federally recognized holidays and weekends.
3. **Hours of operation or place of performance:** The contractor is responsible for conducting all associated services between the hours of 0700-1600 hours, Monday through Friday, no weekends or federally recognized holidays, DINFOS training down days, or unless the installation is closed due to local or national emergencies or similar government-directed installation closings. The contractor must at all times maintain an adequate work force for the uninterrupted performance of all tasks defined within this contract when the government installation is not closed for the above reasons. When providing personnel, the contractor shall keep in mind that the stability and continuity of the services are essential. The contractor must provide a 24 hour emergency service hotline, at no cost.
4. **Contract manager:** The contractor shall provide a contract manager who shall be responsible for the performance of the work. The Contract Manager must be able to read, write, speak, and understand English. The name of this person and an alternate who shall act for the contractor when the manager is absent shall be designated in writing to the KO. The contract manager or alternate shall have full authority to act for the contractor on all contract matters relating to daily operation of this contract.
5. **Qualified Workmen:** The contractor shall provide adequately trained personnel that can perform the duties in accordance with this contract. The contractor shall ensure employees are qualified to operate the required equipment under applicable federal, state, and local laws. The contractor employees shall practice high standards of personal hygiene and maintain a clean, neat appearance while on duty. The following are prohibited: the wearing of open toes sandals or shoes, if sneakers are worn they will have a safety toe. The wearing of any military uniform parts thereof, to include Corps of Cadets uniforms. The wearing of any tank-style shirts or any clothing with objectionable language or graphics.

52.204-13 SYSTEM FOR AWARD MANAGEMENT MAINTENANCE (OCT 2018)

(a) Definitions. As used in this clause--

Electronic Funds Transfer (EFT) indicator means a four-character suffix to the unique entity identifier. The suffix is assigned at the discretion of the commercial, nonprofit, or Government entity to establish additional System for Award Management (SAM) records for identifying alternative EFT accounts (see subpart 32.11) for the same entity.

Registered in the System for Award Management (SAM) means that--

- (1) Data collected from prospective Federal awardees required for the conduct of business with the Government;
- (2) Prospective contractor-submitted annual representations and certifications in accordance with FAR subpart 4.12; and
- (3) Identification of those parties excluded from receiving Federal contracts, certain subcontracts, and certain types of Federal financial and non-financial assistance and benefits.

Unique entity identifier means a number or other identifier used to identify a specific commercial, nonprofit, or Government entity. See www.sam.gov for the designated entity for establishing unique entity identifiers.

Assignees shall be separately registered in SAM. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the EFT clause of this contract.

(3) The Contractor shall ensure that the unique entity identifier is maintained with the entity designated at www.sam.gov for establishment of the unique entity identifier throughout the life of the contract. The Contractor shall communicate any change to the unique entity identifier to the Contracting Officer within 30 days after the change, so an appropriate modification can be issued to update the data on the contract. A change in the unique entity identifier does not necessarily require a novation be accomplished.

(e) WAWF methods of document submission. Document submissions may be via web entry, Electronic Data Interchange, or File Transfer Protocol.

(f) WAWF payment instructions. The Contractor shall use the following information when submitting payment requests and receiving reports in WAWF for this contract or task or delivery order:

(1) Document type. The Contractor shall submit payment requests using the following document type(s):
