3. Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in FAR Subpart 12.6 - Streamlined Procedures for Evaluation and Solicitation for Commercial Items, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a written solicitation will not be issued. Further, Offerors are responsible for monitoring this site for the release of amendments (if any) or other information pertaining to this solicitation.

This synopsis/solicitation reference number Solicitation FA6648-23-Q-0026 is being issued as a request for quotation (RFQ). A Firm Fixed Price award will be made based on lowest price technically acceptable (LPTA) and past performance.

3.3 The provision at 52.212-2, Evaluation - Commercial Items applies to this acquisition.

ADDENDUM to 52.212-2, Evaluation – Commercial Items.

- A. **The offeror must follow the instructions contained herein to assure timely and equitable evaluation of the offer.** The Government will award a **firm fixed priced** contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered.

The following factors shall be used to evaluate offers:

- a. Price
- b. Technical
- c. Past performance

The Government will review quotes and rank them by Total Evaluated Price from lowest to highest. If the lowest priced offer receives an acceptable rating on the **technical evaluation and is deemed to have an acceptable past performance assessment**, that offer represents the best value for the Government and the evaluation process ends at this point, provided the price is found to be fair and reasonable. Award shall be made to that offeror without further consideration of any other offers. If the lowest priced offeror is deemed not to have an acceptable technical rating and an acceptable past performance rating, the next lowest priced offer will be evaluated, and the process will continue until an offeror has an acceptable technical rating and an acceptable past performance rating.

(ii) Technical capability of the item offered to meet the Government requirement; (Your quote package, **MUST** include spec sheets/information brochures for the products quoted in your package. Failure to provide enough information, will result in a determination of quote being unresponsive to the solicitation.)

(iii) Past Performance; Offerors shall provide a list of three (3) of the most recent and relevant contracts performed for Federal Agencies, State, or Local Governments, and/or commercial sources within the past three (3) years of similar project. Provide any information currently available (e.g. letters, metrics, customer surveys, independent surveys, etc.) which demonstrates customer's satisfaction with overall job performance and quality of completed product for the same or similar type contract. - B. A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.
- C. Failure to meet a requirement may result in an offer being ineligible for award. Offerors must clearly identify any exception to the solicitation terms and conditions and provide complete accompanying rationale.

(a) *Acknowledgement of Solicitation Amendments.* The Government reserves the right to revise or amend the solicitation and attachments prior to the offer closing time. Such amendments will be issued electronically by email. In such cases, the amendment will include an announcement of the new closing date and time. The Offeror shall acknowledge all amendments issued by email to the point of contact for this solicitation.

(b) *Exceptions:* Offerors shall identify and explain any exception, deviation, or assumption to the solicitation terms and conditions and provide accompanying rationale. Offerors are cautioned that it is not the Government's intent to incorporate the Offeror's quotes in the resulting award. Offers that fail to furnish required representations or information or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Discrepancies.* If an Offeror believes that the requirements in these instructions contain an error, omission, or are otherwise unsound, the Offeror shall immediately notify the Contracting Officer in writing with supporting rationale as well as the remedies the Offeror is asking the Contracting Officer to consider as related to the omission or error. The Offeror is reminded that the Government reserves the right to award this effort based on the initial quotes, as received, without discussion.

The Government may reject any or all offers if such action is in the public interest and waive informalities and minor irregularities in offers received.
