Section B: Description of the Supplies/Services Required

The 34th Weapons Squadron requires hangar and weapon storage rental for the Terminal Area Employment (TE) phase of the United States Air Force Weapon School (USAFWS) located in Fort Riley. The Hangars will be furnished with office equipment, weapon storage bunkers and aircrew ground equipment. Services and assistance will be provided for the duration of the TE phase from 8 September 2023 to 30 September 2023.

Section C: Justification for Soliciting from a Single Source or Brand Name

Salina, KS regional airport is the only option to support 34 Weapons Squadron, HC-130J division, due to scheduling conflicts at Fort Riley, KS and runway weight requirements limiting HC-130J operations. Salina regional airport offers everything the 34 WPS needs, including, hangar space to protect USAF assets against severe weather, floor space for the JAI rigging of airdrop bundles, contract fuel, and close proximity to our primary aerial range for the duration of the trips during the TDY. Currently, there is no other facility that can meet the minimum storage capacity including the equipment rentals in nearby area of Fort Riley, KS. There are history of 8 contracts that are single soured, not limited to but including FA486123P0055, FA486122P0034, and FA486121P0138 under NAICS 488119, to Salina Regional Airport in the past in support of the Bi-Annual TDYs for USAFWS.

Section D: Efforts to Obtain Competition


Market research conducted determines that this requirement will be awarded to Salina Airport Authority. as a single source purchase under the NAICS 488119 and PSC X1BZ. A Notice of Intent shall be posted on SAM.gov.

In the future, market research shall be performed for similar or like requirements to ascertain if other manufacturers are entering these specified markets that can meet the AFI and/or DoDI standards/requirements.
