1	Is line 0002 72 ft or 72 pieces?	As specified within the RFQ, 72ft.
2	J gate seal comes in 20 FT sections, is that acceptable?	20ft sections are not acceptable. The 86ft long piece must be continuous.
3	In the required company information section located on page 3, item number 6 states that we may not take any exceptions to the RFQ. I would like an opportunity to quote on this as we have made similar parts for other waterway gates out of polyurethane. Our material is superior to rubber in most cases and will outperform it in most environments. May I have permission to quote with exceptions including material and processes to provide a product of like characteristics for this solicitation?
