PURPOSE

The contractor shall provide biohazardous waste management services at the following Albuquerque Area Indian Health Service Facility:

Contract type will be a firm fixed price purchase order with one base year period with four one-year option periods for renewal.

DESCRIPTION OF SERVICES/SUPPLIES

The contractor shall be in accordance with all Federal, State, Local, Tribal and IHS regulations and shall be made with minimal divergence from the schedule established and with minimum disturbance and maximum protection of government personnel, property and general public.

- Regulated Medical Waste and Sharps Disposal
 - Provide monthly pick up of two RC-44 Gallon Tub's containing medical and bio-hazardous waste and sharps.
- Pharmaceutical Waste Disposal
 - Provide quarterly pick up of medication, pharmaceuticals and their components as regulated by federal and local regulations or laws.
- Hazardous Waste Disposal
 - Provide bi-annual pick up of Hazardous Waste items such as Automotive products, Batteries, fluorescent light bulbs and compact fluorescent lamps (CFL), Paint, Garden chemicals and items containing mercury or lead.
- Disposal, transport and treatment will be in accordance with the requirements of Federal, State and Local regulations governing the treatment of such waste.
- Price shall include all delivery charges and taxes in accordance with the statement of work.
- Contractor shall maintain a container maintenance program and shall be responsible for all repairs and maintenance for the duration of the rental agreement.
- Contractor shall be responsible for equipment failure not arising out of abuse or negligence by the government.
- Contractor shall provide Training Support that includes Annual On-Site training covering Blood Borne Pathogens and updates to the OSHA regulations and On-Demand Online training for various compliance items. Annual Training for Pharmacy and Nursing staff on Pharmaceutical Waste Regulations as a refresher and covering new regulations.
- Contractor shall provide Customer Support that includes an Annual On-Site OSHA survey visit and availability of appropriate logs and manifests documenting destruction. Ongoing support to identify controlled substance wastes, hazardous wastes, and other drug wastes to make sure that each is disposed of properly.

- Contractor shall report to any issues with Pick up to the Contracting Officer Representative (COR)
- QUALITY ASSURANCE:
 - General
 - The contractor shall keep current all licenses and certificates necessary for compliance with regulations.
 - The contractor shall inform the COR and AAO DCGM of changes in applicable federal, state, county, or tribal regulations or licensure requirements that may affect the services that are received.
 - Contractor Equipment/Records Inspection
 - The Contracting Officer or the designated COR, reserves the right to inspect and investigate thoroughly the equipment, services and compliance assurance measures of the Contractor during the performance period.

EVALUATION CRITERIA

Quotes received will be evaluated to determine the Offeror's ability to complete all requirements necessary for successful performance under the contract. A proposal which merely paraphrases the requirements stated in the Statement of Work will be ineligible for award. In addition, a quote that addresses only a part of the requirements will be considered unresponsive to this solicitation and unacceptable for award. The quote should show that the requirements stated in the Statement of Work of this solicitation are understood and offer a logical approach for their achievement. The Government will award a Fixed-Price contract resulting from this solicitation to the responsible Offeror whose offer, conforming to this solicitation; will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

1. A current Hazardous Material Haulers Permit issued by the Department of Transportation to perform delivery of services.
 - a. Evidence of compliance as determined by Federal Safety Standards authorizing personnel must be included with the quote detailing a current Hazardous Material Haulers Permit issued by the Department of Transportation to perform delivery of services.
2. Evidences of worker's compensation insurance and liability insurance for all employees, facilities, and vehicles must be included with quote.
3. For the purpose of fulfilling obligations under this paragraph, the Contractor shall procure and maintain during the term of performance, liability insurance in form satisfactory to the Contracting Officer. The amount of the insurance shall not be less than \$100,000 each person, \$300,000 each occurrence and \$100,000 property damage.
 - a. Evidence of compliance must be included with quote.
 - b. The contractor shall indemnify and hold the government harmless for any and all losses, damages or liability on account of personal injury, death, or property damage, or claims for personal injury, death, or property damage of any nature whatsoever and by whomsoever made, arising out of the activities of the Contractor, his employees, subcontractors, or agents under this purchase order.
 - c. Each policy of insurance shall contain an endorsement providing that cancellation by the insurance company shall not be effective unless copies of the notice of cancelation sent via registered mail to the AAO-IHS Contracting Officer 30 days prior to the effective date of cancellation.
4. Price

An award will be made on a best value basis; both price and other factors considered. Offeror's proposal is found to be technically acceptable, based upon the evaluation criteria, and the Offeror is determined responsive and responsible in accordance with the terms and conditions of this solicitation. Evaluation factors 1-3 when combined, are more important than price.

INVOICE

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. - (1) An Offeror is required to be registered in SAM when submitting an offer or quotation, and shall continue to be registered until time of award, during performance, and through final payment of any contract, basic agreement, basic ordering agreement, or blanket purchasing agreement resulting from this solicitation.
 - (2) The Offeror shall enter, in the block with its name and address on the cover page of its offer, the annotation "Unique Entity Identifier" followed by the unique entity identifier that identifies the Offeror's name and address exactly as stated in the offer. The Offeror also shall enter its EFT indicator, if applicable. The unique entity identifier will be used by the Contracting Officer to verify that the Offeror is registered in the SAM.

- "Local taxes" includes taxes imposed by a possession or territory of the United States, Puerto Rico, or the Northern Mariana Islands, if the contract is performed wholly or partly in any of those areas.
- (b) (1) The contract price includes all applicable Federal, State, and local taxes and duties, except as provided in subparagraph (b)(2)(i) of this clause.
- (2) Taxes imposed under 26 U.S.C. 5000C may not be—
- (i) Included in the contract price; nor
 - (ii) Reimbursed.
- (c) The contract price shall be increased by the amount of any after-imposed Federal tax, provided the Contractor warrants in writing that no amount for such newly imposed Federal excise tax or duty or rate increase was included in the contract price, as a contingency reserve or otherwise.
- (d) The contract price shall be decreased by the amount of any after-relieved Federal tax.

(e) The contract price shall be decreased by the amount of any Federal excise tax or duty, except social security or other employment taxes, that the Contractor is required to pay or bear, or does not obtain a refund of, through the Contractor's fault, negligence, or failure to follow instructions of the Contracting Officer.

(f) No adjustment shall be made in the contract price under this clause unless the amount of the adjustment exceeds \$250.

(g) The Contractor shall promptly notify the Contracting Officer of all matters relating to any Federal excise tax or duty that reasonably may be expected to result in either an increase or decrease in the contract price and shall take appropriate action as the Contracting Officer directs.

(h) The Government shall, without liability, furnish evidence appropriate to establish exemption from any Federal, State, or local tax when the Contractor requests such evidence and a reasonable basis exists to sustain the exemption.
