16. REMARKS  The contractor shall perform First Article Test (FAT) and inspection per FAR Clause 52.209-3 First Article Approval-Contractor Testing (FAA-CT) and IAW MIL-PRF-32675. The contractor shall inform the Contracting Officer, in writing, fifteen (15) days prior to the start of FAT. The Initial Draft of the First Article Test Report (FAT-R) shall be submitted to the requiring office within fifteen (15) days of completion of all FAT. The report is to be formatted per MIL-HDBK-831A, material certifications shall accompany the report formatted per DI-MISC-80678. The government will have fifteen (15) days to review and provide comment and request any necessary revisions. The contractor shall then submit a final FAT-R within 15 days after receipt of government comments.  The FAT-R shall include a comprehensive description of all tests conducted, their outcomes, and the rationale for pass/fail occurrences and cover all aspects as stated in CDRL A021, First Article Test & Inspection Plan (FAT & IP) . FAT will be held at a government test agency that is capable of performing all testing per MIL-PRF-32675 and as stated/indicated in this contract.  As part of FAT the contractor shall include Freight on Board (FOB) destination shipping and all necessary costs of contractor site support to maximize the potential for FAT success. Any shipping charges required after that (based on system failure/non-compliance with performance elements) related to rework/repair of FAT systems will be at the contractor's expense and coordinated on their end.  The FAT Plan and FAT Report shall be produced in accordance with DI-NDTI-80566A, DI-NDTI-80809B, and Sections C.3.5 and C.3.8. These documents shall be submitted electronically in MS Office or Adobe PDF format to the Product Manager Force Sustainment Systems Project Engineer. Refer to Section G for contact information. a. Group I. Definition - Data which is not otherwise essential to the contractor's performance of the primary contracted effort (production, development, testing, and administration) but which is required by DD Form 1423.

Estimated Price - Costs to be included under Group I are those applicable to preparing and assembling the data item in conformance with Government requirements, and the administration and other expenses related to reproducing and delivering such data items to the Government.

b. Group II. Definition - Data which is essential to the performance of the primary contracted effort but the contractor is required to perform additional work to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, or quality of the data item.

Estimated Price - Costs to be included under Group II are those incurred over and above the cost of the essential data item without conforming to Government requirements, and the administrative and other expenses related to reproducing and delivering such data item to the Government.

c. Group III. Definition - Data which the contractor must develop for his internal use in performance of the primary contracted effort and does not require any substantial change to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, and quality of the data item.

Estimated Price - Costs to be included under Group III are the administrative and other expenses related to reproducing and delivering such data item to the Government.

d. Group IV. Definition - Data which is developed by the contractor as part of his normal operating procedures and his effort in supplying these data to the Government is minimal.

Estimated Price - Group IV items should normally be shown on the DD Form 1423 at no cost.

**Item 18.** For each data item, enter an amount equal to that portion of the total price which is estimated to be attributable to the production or development for the Government of that item of data. These estimated data prices shall be developed only from those costs which will be incurred as a direct result of the requirement to supply the data, over and above those costs which would otherwise be incurred in performance of the contract if no data were required. The estimated data prices shall not include any amount for rights in data. The Government's right to use the data shall be governed by the pertinent provisions of the contract.
