**1) PROVIDE QUESTIONS AND ANSWERS AS SUBMITTED IN RESPONSE TO THE RFP**

**Q1: When Will the PowerPoint presentation be posted?**

*A1: No later than January 20, 2023.*

**Q2: Will the Multiple Award Schedule, Most Favored Customer (MFC) terms and conditions apply?**

*A2: No – only the terms and conditions outlined in the upcoming solicitation, expected to post June 2023.*

**Q3: How many Toyota units were sold in the previous contract?**

*A3: 133 total Toyota units of mixed makes and models.*

**Q4: Can we make a “ADD MODEL” REQUEST for 2024 Outside the Continental United States (OCONUS) Vehicle Program?**

*A4: Yes, please do so before the February 17, 2023, deadline for model list due to Engineering.*

**Q5: Can you be on MAS Schedule and AutoChoice at the same time?**

*A5: Yes, you may have multiple contracts.*

**Q6: Is the Anticipated Models List final?**

*A6: No; you can offer any vehicle models (even those not on the Anticipated Models List), as long as you submit prior to the due date (February 17, 2023).*

**Q7: Who would be the best contact to discuss the pricing and proposal process??**

*A7: You can reach out to Michael Davidson ([Michael.davidson@gsa.gov](mailto:Michael.davidson@gsa.gov)) and Brent Evans ([Brent.evans@gsa.gov](mailto:Brent.evans@gsa.gov)) in order to schedule a 1-on-1 meeting to discuss any questions. Answers to any questions posed during 1-on-1 meetings will be documented and publicized for all prospective offerors to review.*

**Q8: Will we be required to provide pricing after the solicitation is released or before?**

*A8: Pricing shall be requested after the solicitation is released during the AutoBid phase.*

**Q9: Can we put pricing on contract that is above what we are providing for other customers?**

*A9: Technically yes, there are no contractual restrictions for that as there are on MAS. Prices will still need to be determined fair and reasonable in order to be awarded.*

**Q10: Our vehicle lineup cannot go anywhere except developing countries. You mentioned Middle East and North Africa. Our vehicles are more for Sub-Saharan Africa, Haiti, Central America, etc. Is this a program for us? Should we spend our time on this?**

*A10: Yes, you can certainly include clarifications/collisions that specify countries your vehicles are available for. Also, there will be suffix designations for country specific models. For example, a 105Z would be for Europe, a 105J would be for Japan, 105O would be for open market-North Africa-ME, ect. Each of these makes/models will be coordinated with GSA engineering to ensure compliance.*

**Q11: If an order is placed via AutoChoice, does it have to be fulfilled?**

*A11: An order that is submitted in AutoChoice is a binding order. We are accommodating of special circumstances, but in general, yes, the order is binding.*

**Q12: Are we as the contractor protected from fluctuation of currency exchange rates?**

*A12: No, there is no economic price adjustment for fluctuations in the currency exchange rates. All risks of fluctuation are on the contractor.*

**Q13: If exchange rates go up, what are our options?**

*A13: You will have two Open Season periods per year to propose new / increase pricing.*

**Q14: May a contractor add a caveat to the terms and conditions like an 'ECU' certificate?**

*A14: You can certainly propose it. GSA will have to consult with legal.*

**Q15: AutoVendor/AutoStandards account requests are due February 17, 2023. Do I also need to provide a models list prior to then?**

*A15: Yes, please reference the Anticipated Models List (attached to the Sources Sought Notice on SAM.gov). Prior to February 17, 2023, provide your model list referencing the according line items. Contractors CAN and SHOULD offer models that do not match existing SINS. Due to the expansion of scope (from Europe to OCONUS), GSA would like to further expand the offered models.*

**Q16: If we provide a list of models and account request does that obligate us to respond to the RFP?**

*A16: No, not at all.*

**Q17: Where will vehicle acceptance take place?**

*A17: FOB Destination*

**Q18: Who is GSA's target market? How will GSA market this program to more customers?**

*A18: GSA Fleet and All Government agencies OCONUS.*

**Q19: Will there be a mechanism to add options after-the-fact, at the request of the customer(s)?**

*A19: Yes, there will be ability to add optional equipment to awarded line items based on the Government need, and through the Additional Requirements (AREQ) option for individual customer needs.*

**Q20: Is there an IFF fee?**

*A20: No, you do not have an Industrial Funding Fee (IFF) in addition to the contractual price.*

**Q21: How long has this OCONUS contract idea in the works?**

*A21: The Government has had contracts covering Europe and other various areas OCONUS for around 10 years, but this will be the first time GSA will encompass the entire OCONUS region under one program.*

**Q22: When is a list of optional equipment (and specifications) due?**

*A22: The Government will publish a list of options with each anticipated make/model intended for award. If prospective offerors wish to add additional options, please add those to the Technical Exceptions Worksheet during the proposal submission phase (AutoBid), and engineering shall review those for technical acceptability. Also, based on the Government's needs, optional equipment may be added at any time after initial contract awards, and through the Additional Requirements (AREQ) option for individual customer requirements.*

**Q23: Do all options have to be TAA compliant?**

*A23: Yes, all items offered to the Government shall be Trade Agreement Act (TAA) compliant.*
