Custom Control Sensor (CCS), Inc. is the last successful manufacturer of the 15' Absolute Pressure Switch and the original provider of same item used to support the MK50 Torpedo. The component is a highly complex and technical manufacture with an overarching envelop drawing and the internal components designed by the source to meet the weapon specification requirements. While performing market research the vendor confirmed they maintained the technical capability and resources to manufacture the item. Discussions with the vendor confirmed the item is manufactured in the same location/facility with the same tooling/equipment and personnel as the previous contract awarded in 2013. The suggested source has previously qualified a design to the government drawing/specification requirements under contract N00253-13-C-0006.

[REDACTED] Therefore, the Agency is requesting other than full and open competition under Unusual and Compelling Urgency due to projected MK54 Torpedo Production Impact 10/30/2023. If material is not received by 10/30/2023 the LWT Torpedo Intermediate Maintenance Activity (IMA) will be at a work stoppage resulting in severely reduced Fleet Readiness due to missed weapon deliveries to support scheduled Exercise (EX) events and Warshot (WS) Inventory Objectives, lost IMA capacity, and Gov/CTR labor costs [REDACTED] until new material is received. The program is projecting a production impact between 10/30/2023 and 11/22/2023 based on 300 day production lead time from planned award date 1/26/2023 [REDACTED] and missing 15 Fleet deliveries.

FY23/24 LWT Torpedo requirements requiring the 15' Pressure Switch to support initial MK54 Fleet deliveries account for 75% of the planned workload. Contract actions for this item are regularly briefed during the Critical Project Execution Review (CPER) [REDACTED]
