Section C: Justification for Soliciting from a Single Source or Brand Name

The recently completed 414th CTS MILCON project only provided full infrastructure for the internal proximity access control system. This was a governmental oversight as it only included the wiring, key pads and computer software but did not include the computers/card readers/cards and systems interface equipment. Brand new 42 square foot Top Secret Facility with over 30 doors individually segmented into separate access secure areas all installed and wired by the company "DKR".

Due to the original installation company "DKR" designed the original infrastructure, "DKR" has designed system that is directly compatible and integrated equipment to complete the system modification.

Additionally, "DKR" as the installation company has unique knowledge of the installed portions of the system that will preclude potentially tearing out and reinstalling new components. DKR has directly compatible equipment that has been tested with the installed system components.
