1	How many Government owned cylinders are in use at the same time? How many cylinders are government owned? Are all 111 Aviators? Please explain the anticipated rotation of government owned cylinders to be filled to explain how many are in use, how many are in transit, and how many are at the supplier's fill plant. With the three day turn around, we would like to respectfully understand the pool of government owned assets to meet this turn around/delivery time.	About 50 government owned all onsite, no they are not all aviator, this request is only happening about 30 times a year as of now, this could increase. Government doesn't expect a 3 day turn around, usually they come back on the next delivery usually the next week
2	Alternatively, will the government accept proposals and amend the Scope of Work and Pricing Schedule to allow for Supplier to provide rented cylinders to be included as part of the bid and asset rotation or for supplier rented cylinders to replace government owned cylinders to streamline efficiencies?	No, the "scope of work" nor the "pricing schedule" will be changed.
