VALIANT is being told that the delivery of the Nurse call systems can be up to 5-6 months from the order. The fabrication of the Nurse call exceeds the solicitation period of performance. Since the Nurse call system is an ILSM issue VALIANT wanted to alert the owner, and request clarification as to the contractual period of performance. | If the contractor knows there are long lead times on materials that will impact the contract period of performance, the contractor needs to provide that information in their proposal and request an extension to the period of performance.  | VA                |            |

Is the VA stating that Rauland would be a stand-alone system, but Hillrom can be tied into the existing Hillrom System?  | The Rauland system is a stand-alone system requiring the Head-In equipment located in Room C-411. The Hillrom system is tied into the existing Hillrom nurse call system in room A-454. Room A-454 holds the existing Hillrom nurse call Head-In equipment. Room A-454 is where the Hillrom system will tie-in. With a Hillrom system there is no need for Head-In equipment in room C-411 therefore no need for the additional room in C-411 related to the nurse call Head-in equipment. The restroom renovation of Room C-411 shown on the drawings remains except for the area related to the nurse call Head-in equipment. The area shown in room C-411 related to the nurse call Head-in equipment is deleted from the work. | VA                |            |
