**Q1:** What is the anticipated award date?

**A1:** As soon as possible after quotes due date and before 9.30.23.

**Q2:** What is the anticipated delivery date of the structure when awarded?

**A2:** Without knowing production timelines it would be nice to have the structure before snowfall this winter or in the spring of 2024 with delivery no later than April 1, 2024.

**Q3:** Base Building Item E Exterior Dimensions: Side walls shall be a minimum of 8 ft from prepared surface to curve of arch. Our standard 40' structures have a straight wall of 4' before the curve of the arch (see attached beam section clearances). At 2' from the interior wall the clearance would be 10'5". Will this meet your project requirements, or do you require the full 8' of straight wall?

**A3:** This is acceptable. The clearances in the provided sketch are acceptable for the purposes of the structure.

**Q4:** Optional Building Items #2 Insulation: Provide insulation package for all building surfaces at an R value of R-30. The standard insulation package for our 40' structures is R-25. Will this be accepted?
