RFP Attachment L-5 Instructions and ToC state that offerors shall not change the excel table organization or design within each spreadsheet tab.	The government is amenable to Offerors adding additional tabs to Attachments L-5 (Cost Price Templates) and L-9 (Technical Resources Summary Template and BOE Template) in order to improve traceability of the cost model as long as these do not impact the organization or design of the existing tabs. The government is not amenable to combining Attachments L-5 Cost Price Template and L-9 Technical Resources Summary Template and BOE Template into a single spreadsheet.
