The following data element positions as defined in Incoming Transaction Format will be left blank: 17, 27-28, 38, 114, 158, 209, 215-336.</p> <p>All items shall be preserved and packed in accordance to MIL-STD-2073's definition of Military Packaging.</p> <p>The contractor shall submit Special Packaging Instructions (A010) concurrently with applicable LPD.</p> <p>BLK 7 – DD 250 due with last submission only. All other submissions shall be delivered with a letter of transmittal. The letter of transmittal shall contain an itemized spreadsheet of the data contained within the submission. Contractor shall only invoice upon final government acceptance</p> <p>BLK 10/12: Initial Submission of Logistics Product Data (A011) is due thirty (30) days after acceptance of Final Provisioning Parts List (A008).</p> <p>Block 10/13: Subsequent submittals are due by the 25th of each month until all data has been submitted. Final submission shall be submitted no later than ninety (90) days after government acceptance of initial submission.</p> <p>The government will determine acceptance or rejection within thirty (30) calendar days of receipt of all submissions. a. Group I. Definition - Data which is not otherwise essential to the contractor's performance of the primary contracted effort (production, development, testing, and administration) but which is required by DD Form 1423.

Estimated Price - Costs to be included under Group I are those applicable to preparing and assembling the data item in conformance with Government requirements, and the administration and other expenses related to reproducing and delivering such data items to the Government.

b. Group II. Definition - Data which is essential to the performance of the primary contracted effort but the contractor is required to perform additional work to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, or quality of the data item.

Estimated Price - Costs to be included under Group II are those incurred over and above the cost of the essential data item without conforming to Government requirements, and the administrative and other expenses related to reproducing and delivering such data item to the Government.

c. Group III. Definition - Data which the contractor must develop for his internal use in performance of the primary contracted effort and does not require any substantial change to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, and quality of the data item.

Estimated Price - Costs to be included under Group III are the administrative and other expenses related to reproducing and delivering such data item to the Government.

d. Group IV. Definition - Data which is developed by the contractor as part of his normal operating procedures and his effort in supplying these data to the Government is minimal.

Estimated Price - Group IV items should normally be shown on the DD Form 1423 at no cost.

Item 18. For each data item, enter an amount equal to that portion of the total price which is estimated to be attributable to the production or development for the Government of that item of data. These estimated data prices shall be developed only from those costs which will be incurred as a direct result of the requirement to supply the data, over and above those costs which would otherwise be incurred in performance of the contract if no data were required. The estimated data prices shall not include any amount for rights in data. The Government's right to use the data shall be governed by the pertinent provisions of the contract.
