1.0 Title: Hunter Associates Laboratory, Inc. service contract for DLA Product Test Center - Analytical (TA) Lab located at Philadelphia, Pennsylvania.

2.0 Introduction: The contractor shall provide all personnel, equipment, tools, materials, parts, supervision, quality control and other items and non-personal services necessary to perform Preventive Maintenance (PM) & Calibration Verification (CV) for Hunter, model USPRO, s/n 1371 and s/n 2096, as defined in this Performance Work Statement (PWS). The contractor shall perform to the standards in this contract.

3.0 Background: In 1994, Defense Logistics Agency (DLA) established the Product Testing Center (PTC). DLA consolidated five pre-existing Inventory Control Point (ICP) and Depot testing facilities under a single management office located at the Defense Supply Center Columbus. DLA Troop Support now manages personnel and equipment from the Analytical Testing Facility, previously under Land & Maritime. Effective October 1, 2017, the Analytical/ Chemical Testing Facility realigned under DLA Troop Support at the Defense Supply Center Philadelphia. The PTC does not have the capability to perform the required services. No other government agencies are known to have the capabilities to complete the PWS requirements which are outlined here. Hunter Associates Laboratory is the only known commercial vendor capable of fulfilling this requirement.

4.0 Scope and Tasks: Hunter Associates Laboratory service contract shall cover the following per each contract year:

A. Hunter, model USPRO, s/n 1371 and Hunter, model USPRO, s/n 2096:

1. One (1) on-site inspection, calibration verification, and maintenance on two (2) instruments identified above.
2. Travel and labor expenses.
3. Regional scheduling during the assigned month of travel, notified at least two (2) weeks prior to date of service.
4. Technical Support by continuously factory trained and certified engineers.

5.0 Period of Performance (PoP): The Period of Performance shall be one year of 12 months (1 Jun 2023 to 31 May 2024), plus four (4) additional option years (1 Jun 2024 to 31 May 2025), (1 Jun 2025 to 31 May 2026), (1 Jun 2026 to 31 May 2027), and (1 Jun 2027 to 31 May 2028).

6.0 Work Schedule: work shall be performance between 6:30 a.m. through 6:00 p.m., Monday through Friday. No work shall be performed during weekend or federal holidays. Government will not be paying overtime to the contractor. Work hours are subject to change after award per customer request.

7.0 Quality Control (QC): The Contractor shall adhere to ISO 9001:2015 and NIST traceability, as applicable. 10.0 Security Requirements: Contractor and all associated sub-contractor's employees shall comply with applicable installation, facility and area commander installation/facility access and local security policies and procedures (provided by government representative). 13.1 Equipment: The Government shall supply equipment in need of calibration. All items shall be accountable as Government Furnished Property (GFP).

13.2 Transportation: The contractor assumes responsibility for all shipping / transportation costs to and from the Government's facility of all "Test, Measurement, and Diagnostic Equipment" (TMDE) presented for calibration.

14.0 Invoicing: Payment of invoices will be accomplished by payment through the Defense Finance and Accounting Service. Invoices will be submitted to the Wide Area Workflow system in accordance with DFARS 252.232-7003 Electronic Submission of Payment Requests and Receiving Reports and DFARS 252.232-7006 Wide Area Workflow Payment Instructions within 10 workdays after the conclusion of each service.

15.0 Service Contract Report (SCR): Not Applicable Per FAR Subpart 4.1703.

16.0 Section 508 Compliance: Section 508 of the Rehabilitation Act requires Federal agencies to make their electronic and information technology accessible to people with disabilities.
