AMENDMENT 0004 Q&A**Question #16:**

The packaging section calls out MIL-STD-2073-1. MIL-STD-2073-1 states that the contract must call out the detailed packaging requirements (specific packaging codes). If they are not listed in any contractual documents, attachments, or TDP then the contracting office must be contacted for more information. A simple statement of “pack in accordance with MIL-STD-2073” is not enough information to properly address it in the Offeror's proposal. Can the government provide the specific codes that will be required for packaging to ensure that the Offerors are capturing all costs and covering all requirements in this proposal? Otherwise, the Offeror assumes current contract packaging procedures and processes will be used.

Response:

Current packaging procedures and processes are acceptable.

Question #17:

ECP 982-038 (Notice of Revision (NOR) 4) for drawing 7625770 adds find number (FN) 11 PN M24308/26-1Z as an alternative to FN 11 M24308/26-1(per ECP) but drawing 762770 Rev B FN 11 calls for PN M24308/26-2. We did not find an ECP that changes PN M24308/26-2 to M24308/26-1. We believe this to be a copy and paste error from ECP 972-038 NOR 001 ITEM 6 and should state “M24308/26-2 is obsolete and has been replaced with M24308/26-2Z. On previous revisions of MIL-DTL-24308/26, no suffix for the finish indicated zinc. New revisions of MIL-DTL-24308/26 require a finish be specified. The "Z" suffix added for zinc.”
