Treat to use category UC4B for sills and backing planks. Treat to use category UC3B for all other members. Comply with the requirements of the current edition of WWPI's Best Management Practices for the use of treated wood in aquatic environments.

Hardware: Uncoated. Shall meet the requirements of AASHTO M270, Grade 36, with nuts and bolts conforming to ASTM A307, Grade A.

Screws: Exterior Grade, Torx drive steel screws, of equivalent length/strength, with coating designed specifically for treated lumber and outdoor applications shall be provided in place of all specified nails.
