GENERAL REQUIREMENTS 01 00 10 SECTION 1.9 ITEMS AFFECTING WORK PLANNING ITEM A Is changed to read:

"Safety Representative: Subcontractor Safety Representative is **not** required on the project."

ENVIRONMENTAL, SAFETY, AND HEALTH REQUIREMENTS 01 31 00 1.4 DEFINITIONS item N referencing Subcontractor's Safety Representative/ES&H Manager should be deleted in its entirety.

IV. CHANGE MANDATORY REQUIREMENT OF \$10M OR GREATER FOR EACH OF PAST 5 YEARS TO \$5M OR GREATER EACH OF THE PAST 5 YEARS

RFP Package 1 Proposal Preparation Instructions, SELECTION, Part B, Mandatory Requirements, item 5 is changed to read "Annual Revenues greater than **\$5M** for each of the past five (5) years."
