1) PROVIDE QUESTIONS AND ANSWERS AS SUBMITTED IN RESPONSE TO THE RFP

Q1: Please provide clarification for the SK option. The GSA specification asks us to provide a metric odometer. The odometer can be programmed to display readings in miles or kilometers. Is this the intent of the SK option? If so, we can add our functionality on the technical exceptions worksheet. Or, are you looking for a metric odometer to register an export unit to go overseas?

A1: An odometer that can be programmed to read in kilometers may be acceptable, please indicate the functionality of your option on the Technical Exceptions Worksheet (see Attachment E2), and GSA Engineering will make a determination of its acceptability.

Q2: Can a separate Dealers Layout Form be provided for battery electric vehicles in addition to the one provided for standard vehicles?

A2: Yes, offerors may submit multiple Dealers Layout forms. Please be sure to indicate clearly which form covers which line items.

Q3: New Allocation system, what if the manufacturer can't fulfill orders... Will the letter of supply lock in sufficient supply? This is important given the current supply shortage impacting all vendors. Is there a clause for unforeseen circumstances, example Semiconductor chip shortage?

A3: If a successful offeror has difficulty securing supply of vehicles, they can request that a line item be closed for ordering at any time, and can request to reopen the line item when adequate supply resumes.

Q4: Will cost be locked in or will that be address during open season to make changes?

A4: All contract awards are firm fixed price for each awarded line item and optional equipment. Any price changes submitted during open season periods will be considered (along with supporting documentation justifying the price change), and evaluated for fair and reasonable pricing and awarded on a lowest-price, technically acceptable (LPTA) basis per model per SIN.

Q5: Is there a per diem fee for damage or delay from production?

A5: Please refer to RFP Section C.6 which establishes a per-day concession for unexcused delays.

Q6: During price reduction period of five days, do we have the ability to go lower or only match?

A6: For a price reduction triggered under section C.18, other contractors with awarded line items under the same SIN will have the opportunity to lower their pricing as much as they wish.

Q7: Is there any particular Financial Layout/ Template that is needed when submitting financial data information in Tab C?

A7: Any layout/format is acceptable, but please ensure it includes the following figures for the past three years: gross revenue, net income, current assets, total assets, inventory, current liabilities, total liabilities, equity.

Q8: What proof is needed for SAM registration Tab D?

A8: A printout showing the offeror's active SAM entity registration, or a copy of the email confirmation of SAM registration or renewal is sufficient.

LU Options questions:

Q9: Is there a separate updated branding guide for the LU option packages?

A9: GSA is working on consolidating all law enforcement branding into one guide. The document is not available for release at this time; when GSA releases the guide in the future, the procedure will be either an amendment to the solicitation or via modification to awarded contracts.

Q10: On the LU options, most of specifications on the Ford the specs call for a Whelen Carbide system and on the Dodge a Whelen Core system. Carbide being the older system and Core the newer, is there a preference?

A10: GSA requires OBD provisions. GSA will accept either the CenCom or Core as long as they are equipped with OBD-II provisions. Offerors must determine what approach is most competitive for them, and shall submit exceptions in accordance with instructions if changes are required to the GSA requirements.

Q11: On the LU options, parts identified throughout the specifications reference “GFX”, “GFX Series”, “Havis-GFX kit” or “GFX-Havis” as opposed to manufacturer specific part numbers. This appears to be a an upfitter specific part number, will the manufacturer specific part numbers be provided?

A11: Part numbers will be added to the requirements documents when they become available to GSA. In certain situations, the upfitter may be the manufacturer.

Q12: On the LU options, can OEM specific options be substituted using aftermarket vendors? As an example, Ford Option 63L, rear quarter glass side marker lights, be replaced by equal lights?

A12: Any brand name substitutions should be entered on the Brand Name or Equal worksheet (see Attachment R3). GSA will consider and likely accept such substitutions if sufficient details are provided to determine the acceptability of the substitution.

Q13: On vehicles that have any of the Law Enforcement upfits (LU Options) is there a provision to charge for additional transportation costs from the upfitter to the end user?

A13: All costs and fees, including transportation and destination/delivery charges, should be included in the proposed LU option price.

Q14: Most of the LU Options specify floor mats, in most factory produced Police vehicles there are no provisions to secure these type of floor mats, causing a safety issue.

A14: Please indicate any issues with the provided specifications on the LU Technical Exceptions Worksheet (see Attachment R2), and GSA Engineering will make an acceptability determination.
