The Government reserves the right to change COLS levels of performance at the ELIN prices stated, without further negotiations, by unilateral modification to the Contract. Is this to mean we are to provide unit pricing for all COL Levels as stated on the ELIN schedule?	All ELINs, regardless of quantity, are to be priced.
