Please be advised that VASDHS has authorized an additional one-time job walk to be conducted for the interstitial. The interstitial job walk will be from 10 a.m. to 2 p.m., July 07, 2023 at the VA San Diego Healthcare System, 3350 La Jolla Village Drive, San Diego, CA 92161.

Prior to accessing the interstitial, the following requirements have to be submitted via email for review and approval prior to entering the interstitial areas. Emails: Ernesto.ibarra2@va.gov or juancarlo.pascua@va.gov. The requirements are as follows:

- 1. OSHA and EPA require that the training requirements and its frequencies are determined by the class of asbestos work performed (defined by OSHA 1926.1101). At a minimum, all affected workers must complete Asbestos Awareness Training which Includes the following activities: Inspectors, engineers, and architects who conduct visual inspections from the catwalks in regulated areas and who do not disturb ACM or PACM.**
- 2. At a minimum Half- Face respirator fit testing certificate**
- 3. Full body Tyvek type suit**
