The following have been modified:

QUESTIONS AND ANSWERS

Q1: Is the assumption that each CLIN is for three classes for that locale or one specific class type?

A1: Each CLIN for a single three day session. Per the Statement of Work, "Each session will provide all three (3) levels of training, one (1) level per training day."

Q2: Which classes will be held in-person vs. virtually?

A2: One session, to include all three levels, will be held in person each period. Two sessions, each to include all three levels, will be held virtually each period.

Q3: Is the assumption that for Basic, Intermediate, and Advanced, it will be the same learners for the Base or Option Year?

A3: As there will be three sessions per period, each providing all three levels of training, there may be a mix of students from previous sessions as well as new students, depending on proficiency and need.

Q4: SF1149 Block 28 – Contractor is required to sign this document and return copies to issuing office. How does the Government expect to receive this document?

A4: All offers and associated documents, including the signed copy of the SF1449 should be submitted electronically as annotated in the synopsis.

Q5: PWS Paragraph 5.d. – Course Attendance Rosters shall be presented to the NAVSEALOGCEN training POC upon completion of training course. For the virtual classes, would the roster be returned electronically and for the in-person classes would be paper to be turned in physically to the training POC?

A5: A paper version may be completed for any in-person classes. Please note, an electronic copy of the roster is required to be attached to any invoice.

Q6: PWS Paragraph 8 – Contractor will provide the virtual classroom environment webcast or Web Based Training capability podcast industry standards that allow government access. Does the offeror provide the means? Would either Teams or Zoom allow for government access? In the past Army365 has been used for online training. Is that not the criteria for this training?

A6: NAVSEALOGCEN does not use Army365. The offeror is to determine the means of presenting the virtual trainings. Teams and Zoom would be examples of acceptable platforms.

Q7: Please confirm which blocks on page 1 of the SF1449 should be completed. Also, should the offeror complete and return pages 10-19 SF Continuation Sheet?

A7: Blocks 12, 17, 23, 24, 30a, 30b, and 30c are required to be completed on page 1. Pricing should be completed in the individual Contract Line Item Numbers in pages 10 through 19. Additionally, any fill-in clauses should be completed as necessary.

Q8: Can past performance be included in the submission?

A8: Yes. The Government conducts past performance analysis using Government operated systems, but additional past performance information may be submitted with the offer.

Q9: Are there any page restrictions?

A9: No.

Q10: Is this a new requirement or an existing requirement?

A10: This is a new requirement.

Q11: How many incumbents are there performing this work?

A11: This is a new requirement.

Q12: What are the incumbent names, contract #s, and revenues received under the incumbent contract?

A12: This is a new requirement.

Q13: How many FTEs were on the previous contract? Has the PWS Changed?

A13: This is a new requirement. This requirement is Firm-Fixed Price for training. There are no FTEs.

Q14: What did you like about the previous contract? Dislikes?

A14: This is a new requirement.

Q15: Please provide instructions to offerors.

A15: Please see the solicitation. As this requirement is a Simplified Acquisition, it does not follow the Uniform Contract Format. There is no Section L. All required submission details are noted in the solicitation.

Q16: Please provide evaluation criteria.

A16: Please see the solicitation. As this requirement is a Simplified Acquisition, it does not follow the Uniform Contract Format. There is no Section M. M-215-H004 in the solicitation identifies the evaluation criteria.

Q17: What are your KPIs?

A17: N/A

Q18: If we have a teaming agreement with a subcontractor, does the subcontractor's experience count as experience for the prime?

A18: There is no minimum required experience. Experience for any involved trainers would be considered.

Q19: Could you please clarify if the Microsoft Excel official exam is included in this?

A19: No official exam is included in this requirement.

Q20: On pages 40-41 of the SF 1449 – Response to solicitation – Is there a specific format for submission and do we add the course summaries as an attachment or include on the Supplier Services Sheets on pages 10-19 of the SF 1449.

A20: Course Summary proposal submission format is at the discretion of the offeror.
