SOW

STATEMENT OF WORK

SCOPE

The Contractor shall provide a removable shaft adapter / bearing housing to allow connection of the 1000 HP drive motor with Cotta gearbox in EPSEF to the Kahn dynamometer. The system shall be capable of operating at 1000 HP with speeds of up to 16,500 rpm and include a shaft at least 15 inches long. Limited engineering data is available for Cotta gearbox and Kahn dynamometer shaft interfaces. Onsite evaluation will be necessary to determine required dimensions of components.

BACKGROUND

The Naval Air Warfare Center - Aircraft Division (NAWCAD) has a requirement to provide a dynamometer test stand to be used at the Power and Propulsion Department, Electrical Power Systems Evaluation Facility (EPSEF). The test stand will be used to perform balance checks on water brakes following refurbishment.

REQUIREMENT**CLIN 0001 – Extension Shaft – Quantity 1**

The extension shafts must meet the following requirements:

1. Operational rotational speed of up to 16,000 rpm
2. Maximum torque of 1000 HP
3. Minimum length of 15 inches and no more than 20 inches
4. Must adapt to bearing housing described in CLIN 0002 and water brake spline interface

CLIN 0002 – Bearing Housing – Quantity 1

The bearing housing must meet the following requirements:

1. Bearing housing must adapt to existing Cotta gearbox output pad spline with no modifications to the gearbox
2. Bearing housing must be removable
3. Bearing housing must be capable of operating under the load conditions imparted during operation with the water brake and extension shaft described in CLIN 0001.
4. Bearing housing must employ grease lubricated rolling element bearings. Journal bearings are not allowed.
5. Bearing housing shall employ removable Vespal spline adapters.

CLIN 0003 – System Verification Test

The contractor shall perform a system performance test for 1-hour at 16,500 rpm. Shaft frequency response versus RPM during run-up, run-down, and steady-state operation

shall be included.

CLIN 0004 – Additional Vespal Adapters – Quantity 2

The contractor shall provide spare Vespal spline adapters.

CLIN 0005 – Delivery

All equipment shall be delivered to the following address:

CLIN 0006 – Standard 1 Year Warranty – Quantity 1

52.209-11 REPRESENTATION BY CORPORATIONS REGARDING DELINQUENT TAX LIABILITY OR A FELONY CONVICTION UNDER ANY FEDERAL LAW (FEB 2016)
