1. Contracting Activity: MICC-Fort Knox

2. Description of Action: Airport Usage Fees with a dedicated USPA certified Drop Zone

3. Description of Supplies/Services: The contractor shall provide a dedicated drop zone for parachute operations and training jumps for the US Army Parachute Team (USAPT). Drop zone must be capable of supporting the entire fleet of USAPT Aircraft (2 medium and 3 light aircraft). Currently the USAPT has a training facility on lease at the Laurinburg Maxton Airport within walking distance to this dedicated drop zone. Fort Bragg Installation cannot provide a drop zone for the type of training jumps the USAPT performs. This is a base year with 4 option year requirements. 5. Reason for Authority Cited: Laurinburg/Maxton drop zone is certified by the United States Parachute Association (USPA) in accordance with AR 360-1. The drop zone is open 24 hours per day, seven days a week and is readily accessible to USAPT personnel and fleet of aircraft. Freefall parachuting is not possible over Fort Bragg on a routine basis due to the proximity of FAA Military Operational Area A and the restrictions of FAA Restricted Area R-5311, where parachuting is prohibited because of military fire, joint Army/Air Force aviation exercises, and large tactical airborne exercises. Failure to obtain these parachute training jumps will result in inadequate preparation and training for the USAPT Competition, Tandem, and Demonstration teams

6. Efforts to Obtain Competition: N/A

8. Market Research: Paraclete XP Dropzone is the nearest USPA certified Dropzone in Raeford, NC. The runway at this location is 3,402 ft and is not long enough to support the USAPT Dash 8 Aircraft which requires a 5000 ft runway. Previous vendor was Scotland Aero Services who was contracted to manage the FBO for the LM Airport Commission. Scotland Aero's contract with LM Airport Commission was not renewed after 31 Dec 2022. Laurinburg Maxton Airport Commission has since taken over management of the FBO themselves.
