ATTACHMENT 1 - Q&A

**QUESTION 1:** In reviewing the SOW for the above-mentioned project I am coming up empty handed on locating a product that meets specified requirements regarding the Urethane based Elastomeric coating. Film thickness shall be at least 30 dry mils unless the manufacturer recommends a thicker coat to meet the specification. Membrane shall provide an elongation (ASTM D 412) of >650%, tensile strength (ASTM D 412) 1700 psi (with no reinforcement), tear resistance (ASTM D 1004) 700 lbs/in, energy start approved, a flash point of 110°F, non-volatile (ASTM D 75) 83%.

**ANSWER 1:** This specification is based on the attached White-Knight® Plus/White-Stallion® Plus specification. We used this membrane on Bldg 42, however the Government recognizes this item has product has been discontinued for metal roofs in favor of CPR White Coating. Based on this information, the SOW has been updated and with a revised spec to be closer to CPR. Please notify the Governmetn immediately if there is still difficulty finding an item to mee the revised specifications.

**QUESTION 2:** Do we need to catch the water during the roof power wash?

**ANSWER 2:** As long as there are no paint particulates leaving the roof, there is no need to catch the water. If your water pressure is so strong that it will remove the paint, then water capturing will be necessary.

**QUESTION 3:** Is there a core sample of Roof 1 and 26?

**ANSWER 3:** Building 1 and 26 (CLIN0001 & CLIN0004) have been removed from the scope for this project. Contractors should NOT price CLIN0001 or CLIN0004.

**QUESTION 4:** Is there a maintenance procedure for Bitumen roofs (Bldg 7, 8, and 18)?

**ANSWER 4:** The procedure can be obtained from Garland (the manufacturer of the roof). NOTE THAT THE SOW HAS BEEN REVISED!

**QUESTION 5:** During the site visit, it was mentioned that the award of this project is not based solely on price. Can you describe the evaluation factors that will be used?

**ANSWER 5:** That is true - Award will be made based on both price and non-price related factors. Before submitting a quote, contractors should carefully read the section entitled "EVALUATION" on page 31 of the solicitation which states in part:

"The Government will award a contract resulting from this solicitation to the responsible contractor who submits the best value quote considering price and non-price related factors. Non-Price related factors include the following: Contractor shall provide a short (no more than one (1) page per project) project description (include Customer Name; Location & Dollar Value) and scope description for three (3) roofing projects of industrial/commercial size in the Northeast (included Maine, New Hampshire, Vermont, New York, Pennsylvania and Massachusetts) that include repair of membrane, metal, modified bitumen, and/or elastomeric coating. Types of repair can be spread out across the three projects. Please include references and their contact information...."
