

RFQ Instructions

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a written solicitation will not be issued. This solicitation, **PANNGB-22-P-0000 006139**, is issued as a Request for Quote (RFQ). Full Text provisions and clauses can be found in **Attachment 2**. This procurement is Set-Aside 100% for Small Business. The **NAICS** code is **541613** and the small business size standard is **\$19,000,000.00 EMP**. All proposals must include Company Name, Address, Federal Tax ID, CAGE code, Unique Entity Identified (formally called DUNS number), contact name, telephone number, and email address. The Government intends to evaluate proposals without discussions (except clarifications as described in FAR 15.306(a)).
