ISS book coordination/management for work scope beginning October 1, 2025, are specified within Section 4 and Section 5 of the SOW. Additional book coordination/management for Exploration Programs will be specified during administration as processes and needs for those programs mature.

The total price for each year in Attachment L-02.1 Tab 3 - Total Cost Summary should reflect all fringe, overhead, G&A, fee costs etc. applied to the Government provided ODC values.

Offerors should identify assumptions that are significant to their BOE. The Government will perform an independent analysis of Attachment L-7, Technical Resources Summary Templates (TRST) to understand the distribution of resources and their rollup to the Level 1 WBS.
