The following have been added by full text:

RESPONSE TO VENDOR QUESTIONS

Q1. The SOW states that, "Contractor shall empty 65 locked containers (64-gallon) every four weeks on-site at 35-45 designated locations."

Is the contractor to provide those locked containers? (I saw elsewhere in the SOW that contractors are to provide bins, but I want to clarify whether this requirement is related to the bi-annual bulk shredding or to the container emptying every 4 weeks.)

A1. Yes, contractor is to provide the locked containers. No, it is not related to the bi-annual bulk shredding.

Q2. Are the 35-45 designated locations all on the same compound?

A2. Yes, all locations are located at different buildings on Fort McCoy.

Q3. The SOW also states that, "The Contractor shall provide bulk shredding twice a year (Spring and Fall) of approximately twenty-five thousand (25,000) to thirty thousand (30,000) pounds. Boxes are to be destroyed and will be picked up from a location designated by the COR and transported in a locked truck to shredding plant."

I assume that you require the contractor to provide the locked truck, but is there a shredding plant onsite where the contractor will be directed to shred all documents?

A3. There is no shredding plant on-site. Shredding is to be provided by the contractor on-site with the contractor's shredding truck.
