NOTES TO QUOTERS:

1. This is a solicitation to establish a fixed price, single award, 5-year Indefinite Delivery Indefinite Quantity (IDIQ) supply contract with Economic Price Adjustment (EPA) for Toasted Soy Flour. Quoted prices shall include all costs necessary to supply and deliver the product as described, FOB destination to Edinburg, Texas.
2. This solicitation is issued as a small business set aside. The NAICS code for this acquisition is 311211, with a size standard of 1,000.
3. All quantities are estimates and are not guaranteed. The minimum guarantee under this contract is 750 bags.
3. The Buy American Act applies. See 52.212-1 and 52.212-3(f), Buy American Certificate located at the end of this document. Vendors must disclose and include with their quote, the country of manufacture.
4. Evaluations will be conducted in accordance with FAR Part 13 with award made based on Best Value. (See Provision 52.212-2 at the end of this document for factors). Quoter's are responsible for ensuring completeness of quotations. The Government may evaluate solely on the information provided in the quotation. Quotations that include additional terms may be excluded from consideration. Alternate Pricing Schedules will not be considered.

1.0 PURPOSE

The Mexican Fruit Fly (MexFly) Rearing Facility for the last 28 years has been rearing fruit flies in the Rio Grande Valley. The current production of Mexican Fruit Fly pupae is currently set at 150 million pupae per week. Toasted Soy Flour is used as a vital source of nutrients in the diet for the larval development of the Mexican Fruit Fly. Currently there is no other product evaluated as effective as the Toasted Soy Flour described below. Several years ago, a study was conducted by the Center for Plant Health Science and Technology (CPHST) scientists to produce a diet formula that improved the quality of the Mexican Fruit Flies reared at Moore Air Base for Sterile Insect Release. The purpose of this acquisition is to acquire such food source.

1.1 PERIOD OF PERFORMANCE AND PRICING SCHEDULE

This is a fixed-price Indefinite Delivery Indefinite Quantity (IDIQ) Economic Price Adjustment contract for bio-assayed toasted soy flour. The term of this contract will be for five years. These quantities in the schedule are only an estimate and are not guaranteed. Approximately 750 (25kg.) bags are ordered three times per year, for an approximate total of 2250 bags annually. There is no guarantee that additional items will be ordered throughout the remaining life of the contract, however it provides context for the production possibly needed.

The minimum requirement for this contract is 750 bags. Additional orders are not guaranteed. All unit prices must be inclusive of all costs, including delivery costs FOB destination to the Mexican Fruit Fly Rearing Facility in Edinburg, Texas.

1.2 ECONOMIC PRICE ADJUSTMENT:

Due to the instability and fluctuation in the market pricing of toasted soy flour, the contract includes the clause at FAR 52.216-2 Economic Price Adjustment. The line-item pricing can be increased or decreased depending on the market conditions. Any change in the unit pricing will be evaluated, negotiated, and incorporated into the contract via a modification prior to the start of the production. The only fluctuation allowed in the contract pricing is the cost of toasted soy flour and fuel. Labor, profit, etc. will not be a factor in changing the contract pricing as these are fixed costs throughout the contract period.

The Government anticipates adjusting prices bi-annually, however the contractor may propose a different frequency for the government to consider. The contractor will be required to provide adequate supporting documentation including competitive pricing index, cost breakdowns, and supplier quotes to request any pricing changes. The formula that will be used to make changes to prices (increases and decreases) is below:

Cost of Toasted Soy Flour + Cost of Fuel + Other Cost (labor, profit, etc.)* = unit price

* labor, profit, etc. will remain fixed throughout the contract period and is based on the quoted specified price offered for each option period.

Example:

Ordering Period One

Cost of Toasted Soy Flour + Fuel = \$100 + 100

Other Cost = \$120

Ordering Period One Unit Price = \$100+100 + \$120= \$320

Ordering Period Two

\$50 increase in cost for Toasted Soy Flour and \$20 decrease in Fuel = \$150 + \$80

Other Cost: \$120

Ordering Period Two Unit Price = \$150 + \$80 + 120 = \$350

1.3 DELIVERY ORDERS:

Delivery Orders will be issued as needed over the course of the contract. Orders will be issued by an APHIS Contracting Officer via email. Orders will contain the product being ordered, the quantity being ordered, delivery location, and the delivery date. Economic price adjustments cannot be made to orders once they are awarded, adjustments must be made before funds are obligated.

2.0 STATEMENT OF WORK/SPECIFICATIONS

2.1 REQUIREMENTS

The purpose of this project is to procure Toasted Soy product. The work to be performed under this contract consists of furnishing all materials, equipment, supplies, labor and transportation as required by the Pricing Schedule and in accordance with these specifications. All work materials and services not expressly called for in these specifications but are necessary for completion of the contract requirements shall be performed and furnished by the Contractor at no additional cost to the Government.

2.2 PRODUCT SPECIFICATIONS

The following specifications are required, substitutions will not be accepted: The specification percentages are per 25-kilogram bag. **Substitution of specifications as stated below are not allowed.**

Have a protein content of not less than 50%

Standard Plate Count, 50,000 max.

Must be 20 PDI (toasted)

2.3 QUANTITY

Each shipment shall consist of 750 (25kg) bags.

2.4 BIOASSAY AND QUALITY TESTING.

Prior to each delivery, the contractor shall supply a 1-pound sample bag of the Toasted Soy for testing by the Government. The sample shall be received three weeks prior to each delivery.

The sample will be tested for compliance with Product Specifications (Section 2.3). Samples will be evaluated by the Government within 5 working days from the date received.

2.5 PACKAGING AND DELIVERY

The product shall be packaged in multi-walled paper bags with plastic liners. Product shall be packaged in 25 KG paper bags. Each shipment shall be palletized and shrink wrapped on the pallet. The shrink wrapped pallets shall have not more than 50 bags per pallet for a total of 750 bags per shipment.

2.6 WARRANTY

- A. The contractor shall provide the Government at least the same warranty terms offered to the general public in customary commercial practice. At minimum, the contractor shall guarantee product quality for full compliance with contract specifications, terms and conditions for 60 days from the date of delivery, inspection, and acceptance.
- B. The USDA reserves the right to preform follow up testing for the above contaminants on any shipment received for at least 60 days from the date of delivery, inspection, and acceptance and can return the shipment to the vendor for credit if found contaminated.
- C. In the event the shipment is rejected, it is the contractor's responsibility to replace the product in a timely manner in accordance with contract clause 52.212-4.

(c) If the Contractor's applicable established price is increased after the contract date, the corresponding contract unit price shall be increased, upon the Contractor's written request to the Contracting Officer, by the same percentage that the established price is increased, and the contract shall be modified accordingly, subject to the following limitations:

(1) The aggregate of the increases in any contract unit price under this clause shall not exceed 25 percent of the original contract unit price.

(2) The increased contract unit price shall be effective-

(i) On the effective date of the increase in the applicable established price if the Contracting Officer receives the Contractor's written request within 10 days thereafter; or

(ii) If the written request is received later, on the date the Contracting Officer receives the request.

(3) The increased contract unit price shall not apply to quantities scheduled under the contract for delivery before the effective date of the increased contract unit price, unless failure to deliver before that date results from causes beyond the control and without the fault or negligence of the Contractor, within the meaning of the Default clause.

- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—
